U.S. Exhibitors: Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in U.S. funds it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par" as they will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and co-operation is appreciated. Thank you.

FEES / CHEQUES / N.S.F. CHEQUES:

All fees must accompany your entries. No entries will be accepted without accompanying full payment. Tendering of an N.S.F. cheque or credit cards that have maxed out shall be considered an offence punishable by disciplinary action and cancellation of awards by the Canadian Kennel Club. There will be a \$50.00 fee charged for any N.S.F. funds issued to the Prince Albert Kennel & Obedience Club. (Post-dated cheques will NOT be accepted). Overpayment of entry fees will not be refunded.

OFFICIAL CKC ENTRY FORMS

ENTRIES MUST BE TYPED OR DISTINCTLY PRINTED. Owners are responsible for errors on entries. Incomplete entry forms must be returned to the designated owner or his authorized agent. Unsigned, telephone, or telegraph entries cannot be accepted, except in the event of a postal strike when telephone entries may be made in accordance with the Canadian Kennel Club Regulations.

The following **CKC OBEDIENCE** classes will be offered:

Pre-Novice; Novice A; Novice B; Novice C; Novice Intermediate; Open A(H); Open A(18); Open B(H); Open B(18)
Utility A; Utility B; Exhibition Only.

Refund of entry fee is allowed for bitches in season provided a signed certificate is provided from a veterinarian

CHAPTER 4 – JUDGES

4.1.3. A judge officiating at a show held under these Rules shall not be subjected to INDIGNITIES of any kind during the progress of the show, and it shall be the duty and obligation of the club holding the show to see that this Rule is effectively carried out.

GENERAL INFORMATION

1. Due to limited space, there will be no EX PENS allowed for benching at this trial.
2. THE BOTTOMS OF ALL WIRE CRATE BOTTOMS MUST BE LINED WITH PLASTIC SUPPLIED BY THE OWNER/HANDLER.
3. As per CKC rules all dogs on the show premises ***MUST be listed in the show catalogue.*** Any dogs not listed will be asked to leave. If you have a dog at the show that is not entered you must obtain an "IN TRANSIT" ticket from the Show Secretary (no charge). **Because we have limited benching space, please leave your extra dogs at home.**
4. DOGS MUST BE EXERCISED IN THE DESIGNATED AREAS ONLY. NON-COMPLIANCE WILL RESULT IN IMMEDIATE EXPULSION FROM THE SHOW. POOP/SCOOP RULES ARE **STRONGLY** IN EFFECT!
5. We recommend booking your Hotel Reservations early.
6. Entries will be acknowledged after entry by DogShow.ca and a judging schedule will be available after the closing date. If such acknowledgement is not received one week before the show date, please contact the Show Secretary
7. Entry fees will not be refunded for cancellation of entries if the dog is absent, disqualified, excused by a veterinarian or judge, or barred from competition by action of the Show Committee, or because it has been entered incorrectly.
8. If because of riot, civil disturbance or acts beyond the control of the Club, it is impossible to open or complete the show, no refund of entry will be made.
9. ****NOTE TIME!! The show building will be opened Friday, at 6:30 PM (NO SOONER) to 9:30 PM** for exhibitors to set up. The building will be open from 1 hour prior to the starting of the trial until 1 hour after completion of the trials – time available upon publishing of Judging Schedule.
10. Any show official, volunteer, employee or exhibitor shall not be subjected to any indignity by anyone at these shows. Should this occur the offender may be excused from the show/building by the Show Superintendent or his/her representative.
