# **Judging Schedule and General Information**

The schedule was prepared as quickly as possible...please allow for errors.

\*\* All times listed are Eastern DAYLIGHT Time\*\*

The Conmee Community Centre is a new venue for LKC. We expect all exhibitors to keep the area clean, which means picking up after your dog, and not leaving garbage, topknot elastics, discarded ribbons/armbands, and excess fur in the parking lot and surrounding area. It is wide open and would be impossible for the club to clean up after the show.

We hope we will be allowed back next year!

While the province has opened up a level, we are able to relax some of the restrictions that were listed in the premium list. The information/restrictions listed below may be amended as directives are received from Ontario Health Services.

Let's get through the first area show in 2 years, safely!

#### **Show Hours**

Exhibitors are not to arrive more than 1 hour before the judging of their breed, and should leave after their dog is no longer required for competition.

No one may go on the rink surface during the show weekend except during show hours.

There will be security during the off hours..

#### **WAIVER**

A copy of the attached waiver MUST be signed and dated the 1<sup>st</sup> day the exhibitor attends the show, and submitted upon arrival.

ALL EXHIBITORS, HANDLERS, ASSISTANTS, VOLUNTEERS AND SHOW PERSONNEL MUST SIGN A WAIVER! Each person will be given a wristband.

NO WAIVER = NO WRISTBAND = NO ENTRY!

#### **MASKS & SOCIAL DISTANCING**

Masks are *mandatory* while on the rink surface. Social distancing shall be practised while on the rink floor.

Masks optional in parking area. Please allow at least 6' between vehicles.

#### **GROOMING**

You may now groom *BEHIND* your vehicle ...ONE TABLE/VEHICLE ONLY! Pop-up tents NOT allowed; however umbrellas or shade tarps allowed at back of vehicle.

Blow dryers & generators NOT allowed!

Please keep your area clean...we can't sweep the parking lot!

#### THE RINK & RINGS

The rink floor is concrete, with a slightly rough texture. The rings will *NOT* be matted. Exhibitors are encouraged to wear suitable shoes.

While spectators may *NOT* be on the rink surface, we can now allow the dog's owner as well as handler/assistant to be at ring side (social distancing in effect), but must leave the rink when the dog is no longer required for judging.

Exhibitors with more than 1 dog in the breed, may bring a crate to ringside. Tables, towels/rugs etc NOT ALLOWED on the rink surface.

#### CANTEEN

Conmee has offered to open its canteen during show hours.

Covid 19 restrictions will be posted at the canteen. NO DOGS ALLOWED INSIDE BUILDING/CANTEEN!

#### **RIBBONS**

There will be no recycling of ribbons. If you don't intend to keep a ribbon, please leave it on the ring steward's table. (The photographer will have a full set of ribbons for photos)

Ramps & Tables: A ramp will be available should a judge require one. CKC Rules: At the discretion of the judge, designated ramp breeds (See Appendix H – List of Breeds that may be judged on a ramp) may be examined on the ground or on a ramp. The entire entry in a breed is to be examined in the same manner on the ramp or on the ground. Breeds not designated as either table or ramp breeds are customarily examined on the ground. At the discretion of the judge, ramps may be used to judge any breed. The entire entry in a breed is to be examined in the same manner.
