BABY PUPPY COMPETITION will be judged separately, on Saturday by Tina Sandford and on Sunday by Collin Veinot.

Judging will commence at 8:00 am unless entries warrant an earlier or later starting time. All Group Judging will commence on completion of Breed Judging within each group.

It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue. (19.7)

It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer or competitor at an obedience or rally trial held under these regulations is not subject to indignities of any kind. The Trial Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue. (20.7)

No person may approach a judge either directly or otherwise, orally, in writing or electronically, to favour his entry. Disciplinary action will be taken against any person who violates this rule, or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the action. (4.1.5)

ENTRY INFORMATION

- 1. All entries must be received on or before the closing date and time, accompanied by the proper fees and submitted on an Official CKC entry form. No entry will be accepted unless accompanied by proper entry fees and forms.
- 2. **Please type or print clearly.** Remember your entry can only be as accurate as the information you provide. The Show Secretary (or Entry Service) is NOT RESPONSIBLE for incorrect information provided by the entrant. Moving class dogs to specials is permitted. An error in the class, date of birth or sex may be amended on the entry form up to one hour before the start of the show.
- 3. **INCOMPLETE ENTRIES WILL BE RETURNED.** Agents and Handlers, please note that **full name and address of owners <u>MUST</u> be filled in and to whom ID's are to be returned. (Section 13.1.2, Dog Show Rules)**
- 4. Exhibitors must abide by errors made in entering their dogs regardless of how or by whom entries were made. Please review email confirmations so corrections may be made **prior to closing date** to avoid disappointment. It is YOUR RESPONSIBILITY TO VERIFY the receipt of any electronic entries before the advertised closing date. A valid means of payment must accompany all entries. Until the closing date any changes to your entry can be made via The Entry Line (if that is how you did your entry), after the closing date please contact the Show Secretary.
- 5. To comply with CKC regulations, we will be unable to accept or substitute any entry reaching the Show Secretary after the closing date and time.
- 6. Only dogs entered in the Shows may enter the venue. The Committee reserves the right to refuse any entry subject to CKC rules. Service Dogs are welcome
- 7. The CKC will not consider a request for any corrections to results if received more than 90 days following the date(s) of the event(s).

All entries paid by Credit Card, Debit Card, or eTransfer MUST be done via The Entry Line.

A Canadian Kennel Club TCN (Listing) fee is payable if entry for dogs does not include a CKC Individual registration number. A litter registration is not acceptable. Official CKC entry forms must be used. **Please photo copy and/or print extra entry forms as required.**

- Exhibitors entering both Obedience and Rally must fill out separate entry forms.
- Personal cheque or Money order for the full amount only will be accepted and should be made out to:

- No post dated cheques accepted. All NSF cheques will be subject to a charge of \$25.00. NSF cheques are considered non-payment of entry fees and are punishable by disciplinary action and cancellation of awards. All fees must be paid before the show.
- Entries must be submitted by mail (to the Show Secretary), hand delivered (to 214 Crossley Ave, Truro NS) or via the Entry Line. No other entry service is authorized to take entries for these events.

Please Note: Credit Card payments/Fax Entries/eTransfers accepted ONLY through THE ENTRY LINE. The Moncton Kennel Club does not accept credit cards for payment.

Important Note Regarding Emails & Faxes: It will be the responsibility of the exhibitor to ensure that any electronic submission, either email, facsimile, or any document transmitted electronically, reaches the proper authority or recipient, within the times and limits as regulated for each document in the CKC Rules and Regulation. Sent fax receipts, and/or , copies of sent emails, will not be taken as evidence of receipt by recipients.

REFUND POLICY

The Moncton Kennel Club has instituted the following refund policies. Up to May 23, 2024, 8:00 am AST refunds should the show be cancelled shall be 80%. Remainder will be kept by the Club to cover costs. Once the show starts there shall be no refunds.

REFUND INFORMATION ~ COMMUNICABLE DISEASES

Entry Fees will be refunded for dogs/bitches that are posing a threat of a COMMUNICABLE DISEASE on the day of the show. To obtain the refund, a letter from a practicing Veterinarian MUST be presented to the Show Secretary prior to the commencement of the show.

REFUND INFORMATION ~ OBEDIENCE & RALLY-OBEDIENCE (BITCHES IN SEASON)

Bitches in season are not permitted to compete. The judge of a trial must remove from competition any bitch in season or any bitch that appears so attractive to males as to be a disturbing element.

When a bitch comes into season after entries have closed, she may be withdrawn from the trial and the trial-giving club must refund the entry fee and listing fee providing the Trial Secretary receives, on or before the date of the trial, a veterinarian's certificate declaring that the bitch was in season within the 10-day period preceding the trial.

Attention Foreign exhibitors: Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted; however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated. Thank you

Junior Handling (Conformation)

Junior handling will be held on Saturday only, during the lunch break. All classes will be offered. Dogs competing in Junior Handling must be entered in the show in one of the regular classes or in exhibition only. To sign up to participate, do so, at the Show Secretary's table prior to 11:00 am. Entry Fee is \$2.00, correct change is appreciated.

Rules

A copy of the rules pertaining to Conformation Shows or Obedience Trials & Rally-Obedience Trials may be obtained from the Canadian Kennel Club. It is the exhibitor's responsibility to know the rules pertaining to these events.

Temporary Competition Number (TCN) - Effective January 1, 2023

Temporary Competition Number (TCN) must be obtained before submitting an entry for an event. The same TCN must be used for all event entries for a dog until the dog is permanently registered. Once a dog is permanently registered or has an ERN, the TCN will be replaced with the registration number or ERN. A TCN cannot be used for dogs that will require a Performance Event Number (PEN) or Canine Companion Number (CCN). Listed Breeds that do not yet have a Miscellaneous Class Number (MCN) number will be eligible to apply for a TCN.

There is no fee to obtain a TCN however exhibitors will still be required to pay TCN Fees (formerly called Listing Fees) when entering events using a TCN.

TCN Numbers may be obtained online via the CKC website where the number is issued instantly. Exhibitors may also mail in a printed application or contact CKC Shows and Trials by phone for a number.

Event Registration Number (ERN)

All dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will require an Events Registration Number (ERN) from the Canadian Kennel Club. **Effective January 1, 2023**, the policy has been changed to allow Listed Breeds registered with a different Canadian registry to also apply for an ERN. Canadian Born dogs that are registrable by a breed association in Canada recognized by Agriculture Canada may obtain an ERN.

To obtain an ERN simply do the following:

- 1. Send a photocopy of the dog's registration certificate reflecting current ownership to CKC, for example AKC Registration Certificate with a written request for an ERN.
- 2. Include with the above a cheque or money order in the amount currently required payable to the Canadian Kennel Club.
- 3. Ensure that you provide your full return address to enable to enable the ERN to be sent to you.
- 4. Faxed requests will be accepted. Please indicated your Visa/MasterCard number expiry date, cardholders name and signature.

This Event Registration Number MUST be applied for within 30 days of the first day of entering a CKC event. Dogs may be entered as "LISTED", however, failure to apply for an ERN within 30 days will result in cancellation of any wins, awards or scores. Please forward your request to:

ENTRY INFORMATION

1. All entries are to be sent to the Show Secretary and must be received on or before the closing date and time. Official CKC Entry Forms MUST be used. Please PRINT OR TYPE YOUR ENTRIES. Remember your entry can only be as accurate as the information you provide. The Show Secretary is NOT RESPONSIBLE for incorrect information provided by the entrant. Moving class dogs to specials is permitted. An error in the class, date of birth or sex many be amended on the entry form up to one hour before the start of the show.

- 2. No entry will be accepted unless accompanied by proper entry fees and forms.
- 3. Incomplete entries will be returned. Agents and Handlers please note that full name and address of owners must be filled in.
- 4. Exhibitors must abide by errors made in entering their dogs regardless of how or by whom entries were made.

5. To comply with CKC regulations, we will be unable to accept or substitute any entry reaching the show/trials Secretary after the closing date and time.

6. Only a dog individually registered, or eligible to be registered, in the stud book of the CKC may compete in these shows. The Committee reserves the right to refuse any entry subject to CKC rules.

7. All entry confirmations and Judging Schedules will be sent as soon as possible after entries close.

8. It is YOUR RESPONSIBILITY TO VERIFY the receipt of any electronic entries prior to the advertised closing date. A valid means of payment must accompany all entries.

GENERAL INFORMATION

- The Moncton Kennel Club, its officers, associates and Show Committee, will use due care and diligence for the safety and welfare of the dogs and exhibitors but will not be responsible for, or assume any liability in the event of an accident or misfortune, to either dogs, exhibitors, or patrons. The Moncton Kennel Club will not be responsible for equipment left in the building or on site overnight.
- The Superintendent will be in complete charge of these shows and trials, which are governed by CKC rules
- The Coliseum will be open no earlier than 2:00 PM on Thursday May 23rd for set-up. The building will be open at 7:00 AM daily.
- To comply with the City of Moncton regulations, NO SMOKING WILL BE PERMITTED WITHIN THE CONFINES OF THE BUILDING.

• NO DOGS ARE ALLOWED TO BE LEFT IN THE BUILDING OVERNIGHT.

- BAIT MUST NOT BE THROWN on the conformation ring floors.
- Dogs should be on standby at their respective areas 30 minutes prior to commencement of judging. Judges are not required to wait for late arrivals and will adhere as closely was possible to the Judging Schedule. There will be no PA system used to call dogs to the ring. It is the exhibitor's responsibility to have the dog in the ring when the dog's class is called to be judged. It is the responsibility of the owner/ handler to advise that a dog is absent.
- Handlers and exhibitors with several breeds must arrange for alternative handlers should judging times of different breeds conflict.
- Only a dog individually registered, or eligible to be registered, in the stud book of the Canadian Kennel Club may compete in these shows and trials.
- Please keep your dogs crated when unattended, and clean up after your dogs.
- SHOW & TRIAL PRECINCTS The precincts of these shows and trials will be the building and its entrances.

CHAMPIONS & CHAMPIONSHIP POINTS

SECTION 1: A dog awarded WINNERS at a championship show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5) and the determination of the number of championship points to be credited to a dog awarded WINNERS shall be as provided hereunder.

SECTION 2: The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows:

Dogs Competing:	1	2	3-5	6-9	10-12	13 or more

*Includes the dog awarded WINNERS						

To determine the number of championship points earned by a dog awarded WINNERS total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best of Opposite Sex and then consult the schedule set forth above. The new system provides for additional points (provided that the dog has defeated another as listed hereunder):

POINTS FOR RESERVE WINNERS FOR NATIONALS

At a single breed National Specialty, the male/female designated Reserve Winners Dog/Bitch will be awarded three (3) championship points, provided that the number of dogs competing in the regular classes is sufficient for the Winners to have received 5 points.

BREEDS COMPETING AT GROUP LEVEL

A class dog awarded Best in Show at an all-breed championship show will be credited with five (5) points inclusive of any points earned at the breed or group level. In no case may a dog earn more than five (5) points at any single show.

GRAND CHAMPIONS and GCH POINTS

15.2.1 The title of Grand Champion may only be earned after the completion of the CKC conformation championship. 15.2.2 Points for this title are only accumulated after the completion of the conformation championship and do not include the points earned in attaining the conformation championship. Section 15.2.3 To be awarded a Grand Champion title, a dog must attain a minimum of 20 points, which must include a minimum of two (2) wins of at least two (2) points each. Points may be gained at breed, group or Best in Show/Specialty level. Only the highest points earned at a single show are carried forward.

a) Grand Champion Point System Points towards the Grand Champion title are attained at breed level and are awarded to Best of Breed, Best of Opposite Sex, Select Dog and Select Bitch. Points are calculated based on the number of animals competing at the breed level for the Best of Breed winner and the number of similar-sex dogs competing for the other three (Best of Opposite, Select Dog, Select Bitch).

The following schedule shall be employed in the determination of points awarded at breed level for all levels of GCh:

c) In order to obtain a Grand Champion title, a dog must obtain at least two (2) points after 12 months of age. In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for Grand Champion points.

d) Only the highest points earned at a single show are carried forward.

15.2.4 Grand Champion Bronze (GChB)

The title of Grand Champion Bronze may only be earned after the completion of the CKC conformation title Grand Champion is attained.

a) Points for this title are only accumulated after the completion of the Grand Championship, and do not include the points earned in attaining the Grand Championship.

b) To be awarded a Grand Champion Bronze title, a dog must attain a minimum of 50 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/Specialty level. Only the highest points earned at a single show are carried forward.

c) Points accumulated prior to July 1, 2021 may be used to attain the GChB title, however, a minimum of five (5) points must be earned after July 1, 2021.

15.2.5 Grand Champion Silver (GChS)

The title of Grand Champion Silver may only be earned after the completion of the CKC conformation title Grand Champion Bronze is attained.

a) Points for this title are only accumulated after the completion of the Grand Champion Bronze is attained, and do not include the points earned in attaining the Grand Championship Bronze.

b) To be awarded a Grand Champion Silver title, a dog must attain a minimum of 100 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/ Specialty level. Only the highest points earned at a single show are carried forward.

15.2.6 Grand Champion Gold (GChG)

The title of Grand Champion Gold may only be earned after the completion of the CKC conformation title Grand Champion Silver is attained.

a) Points for this title are only accumulated after the completion of the Grand Champion Silver is attained, and do not include the points earned in attaining the Grand Championship Silver.

b) To be awarded a Grand Champion Gold title, a dog must attain a minimum of 200 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/ Specialty level. Only the highest points earned at a single show are carried forward.

Section 15.3 Grand Champion Excellent and GCHEX Points

15.3.1 The title of Grand Champion Excellent may be granted only after the completion of the CKC Grand Championship Silver Title. Exhibitors will be required to submit to Shows & Trials the Grand Champion Excellent Record Sheet documenting the additional requirements. The Grand Champion Excellent Record Sheet Form is located on the CKC website.

15.3.2 To earn the title a dog must have earned the following during their career as a Special:

a) One (1) Best in Show or a Best of Breed at a breed national specialty (where a minimum of 10 dogs have competed). b) Three (3) Group 1st, or three (3) breed specialty Best of Breed wins.

c) A CKC performance title from any CKC Event. Titles excluded are: CGN, Herding Novice Tested Certificate, all Instinct titles from all events, as well as all Sprinter titles and all Chase Ability Program titles.

15.3.3 Best in Show, Best of Breed at a National Specialty, three (3) Group wins, or three (3) Specialty Best of Breed wins, must be attained after the completion of a regular championship. The performance title may be attained at any time in the dog's career.

NOTE: Grandfathering of the previous version of the Grand Champion Excellent title will be honoured up until December 31, 2022.

To help promote purebred dogs and the dog sport to the public, the Moncton Kennel Club will be taking pictures and livestream video to stream on our social media channels throughout the weekend. By participating in this event, you consent to the Moncton Kennel Club using any images or video footage taken in connection with the Shows and Trials.

All exhibitors will be held responsible for CLEAN-UP in the Coliseum Complex building, on the show grounds and surrounding areas, for their own dogs or dogs they are handling. Additionally, CLEAN-UP after your dog(s) at your motel or campground.
