TO access drive to the second entrance (from the South) on Haida Drive. The **Arena (OBEDIENCE AND RALLY O)** is the first building and the Ag Rec is the second building. Drop-Off is on the East side of the fence and load-in and out is from the front. Your items must be transported about 50' to the building. Four-Way flashers required during the move in. Parking is in the large lot adjacent to the east (front) side. **NO STOPPING IN FIRE LANES.**
