## ADDITIONAL INFORMATION

- ◆ The scoop-up requirements will be strictly enforced.
- ◆ There will be **no "In Transit"** area provided.
- ◆ There will be no "over night" kenneling.
- ◆ Only approved CKC collars will be allowed.
- ◆ SHOWING correct information on the entry form is the responsibility of the entrant. However, Exhibitors incorrectly entered in the "A" class are permitted to move the dog to the corresponding "B" class up to one hour before the start of the trial. The SKOC takes no responsibility for omissions or errors made on the entry forms. The Show Committee reserves the right to refuse any entry subject to the CKC rules.
- ◆ THE PRECINCTS of these trials shall be the training building and paved parking lot
- ◆ KNOWLEDGE of the Canadian Kennel Club Rules is the responsibility of the entrant. Rule books may be obtained from the CKC, 200 Ronson Drive, Suite 400, ETOBICOKE ON M9W or online at <https://www.ckc.ca/en/Files/Forms/Shows-Trials/Event-Rules-Regulations/Obedience-Trial-and-Rally-Obedience-Trial-Rules-an>
- ◆ The SKOC will use due care and diligence for the welfare of the dogs and exhibitors but will not be responsible for or assume any liability in the event of an accident or other misfortune, either to dogs, exhibitors or spectators.
- ◆ All dogs must be under complete control at all times.
- ◆ 20.7 It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at an obedience or rally trial held under these regulations, is not subject to indignities of any kind. The Trial Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.

### PLEASE NOTE:

**When entering the same dog in multiple classes a separate entry form MUST be filled out for EACH class.**

**There will be no food or drinks available for purchase.**

*Payment may be made using a credit card (VISA, MasterCard, American Express). Paper entries can only be paid by cheque.*

## COVID-19 CKC ALLOWABLE CHANGES

- ◆ Six (6) handlers allowed per walk through, in running order.
- ◆ Only the dog and handler in the ring and the dog and handler on deck are allowed in the building (subject to COVID-19 guidelines) during class.
- ◆ For off leash classes, the handler will place their leash in a designated spot and pick it up after their run. The ring steward will NOT bring your leash to you. Your dog must leave the ring on-leash and under control.
- ◆ Armband Numbers will be available to be picked up by handlers on way to the ring for the walk through.
- ◆ Qualifying Rosettes, ribbons and score sheets will be left near entrance/exit for handlers to pick up if they wish after award presentation of their class and removed prior to the end of the next class. No ribbon/rosette presentations in the ring.
- ◆ There will be no printed catalogues. Electronic copies will be provided by email to all exhibitors.
- ◆ Printed courses may not be available.
- ◆ All courses will be posted inside and outside the building.
