The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual. In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.

The fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to Canadian Kennel Club members.

GENERAL INFORMATION

1. No entries may be accepted, altered, cancelled or substituted after the official closing date and time for entries except as provided for in the rules.

2. Bitches in Season: Refund of entry will be made on bitches that come in season after entries close. Request in writing must be submitted to the trial secretary with a certificate how or who made thm

3. In Canada an obedience or rally title can be earned with three (3) qualifying scores under two (2) different judges.

4. Exhibitors should note that the CKC does not confer a title on a dog until it is registered with the CKC -- full registration, ERN, CCN or PEN.

5. A dog which has earned its CD title is not eligible for entry in the Novice A class and no handler who has earned a CDX may handle in this class. A dog which has earned its CDX title is not eligible for entry in the Open A class and no handler who has earned a UD may handle in this class.

6. Exhibitors must abide by any errors made in entering their dogs, regardless of how or who made the errors.

7. It is the responsibility of the exhibitor to have the dog at ringside when the dog's class is scheduled for judging.

8. If entering a dog in Open or Utility and Rally Advanced or Excellent, PLEASE MARK JUMP HEIGHTS ON ENTRY FORMS.

9. The Trial Committee will use due care and diligence for the welfare of the dogs and exhibitors, but will not be responsible for or assume any liability in the event of an accident or other misfortune to either dogs, exhibitors or patrons.

10. The precincts of the trial will be 3 feet around the ring.

11. If because of riot, civil disturbance or any other acts beyond the control of the club, it is impossible to open or close trials, no refund will be made.

12. Section 20.7 Obedience Trial & Rally Trial Rules and Regulations:

It shall be the duty and obligation of the trial giving club to see that a judge, club official, ring Stewart, volunteer or competitor at an obedience or rally trial held under these regulations is not subject to indignities of any kind. The Trial Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
