

## **NOTICE TO ALL CANADIAN RESIDENTS ONLY**

*New CKC Rule*

*Section 24-12-3 Non-member Participation Fee*

*a) An annual non-member participation fee for award and titles will be charged to a Canadian non-member of CKC*

*b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.*

**LIMITED ENTRY** *When Judges' assignments have reached 7 hours, entries will close automatically, even if the official closing date has not arrived. CKC Rule 4.3.3.: The 7 hours is based on the formula of 9 Pre-Novice entries, 8 Novice entries, 7 Open entries, 6 Utility entries per hour and 20 dogs per hour for Rally. When the advertised limit has been reached, all remaining entries may be assigned a position (by class) on the reserve list. The person making the entry shall be notified of his/her position on the list. In the event the entry of a bitch in season is pulled after the closing date, it may be substituted with one from the reserve list up to, and including, the day of the trial.*

**SAME DAY ENTRIES** *A dog that is registered in the records of the CKC or has a PEN, ERN, MCN or CCN number may enter on the same day of the trial, however, a new entry form must be completed by the owner or handler and submitted to the trial secretary, along with the appropriate fee (\$40.00 per dog, per trial) at least one hour prior to the scheduled start of the trial for which the dog is being entered, schedule permitting. The trial secretary shall amend the judge's book and the marked catalogue, which is to be sent to the CKC.*

**MOVING UP** *The transfer must be on the appropriate move-up form and submitted to the Trial Secretary by the owner or handler at least 15 minutes before the start of the class.*

**GENERAL INFORMATION** *Trial precincts shall be the interior of the Canine Coaching Club. The Superintendent will be in full charge of the trials, which will be governed by CKC rules. The Thunder Bay Kennel & Training Club and the Trial Committee will use care and diligence for the welfare of all dogs, exhibitors and spectators, but will not be responsible for, nor assume any liability in the event of an accident or misfortune, however caused. If because of riot, civil disturbance or other acts beyond the control of management, it is not possible to open or complete the trials, no refund of entries will be made. Refunds will be made when a bitch entered in the Trials comes into season after entries close if a Veterinarian's certificate is delivered to the Event Secretary before the date of the trial. Entry fees will not be refunded should a dog be absent, sick, lame or excused by a Veterinarian, Judge or Superintendent. It is the responsibility of the exhibitors to have the dog at ringside when the dog's class is scheduled for judging. The exhibitor is responsible for knowing and complying with the CKC Obedience and Rally Obedience Trials Rules. It shall be the duty and obligation of the trial club to see that the judges, club officials, ring stewards, volunteers or competitors at the trial held under these regulations are not subject to indignities of any kind.*

Just a few rules to remember to keep things rolling along, to ensure that the facility will invite us back again and to welcome everyone to return to our trials and shows.

- Be sure to be on time for your walk through/event and have your dog ready when your number is called.
- Dogs must be crated at all times, except when performing their event or in the ready ring. We want to keep the building entrance and aisle way clear for accessibility to the ring and exit.
- The warmup ring will be marked out and the next dog in the ring will be given priority for warming up.
- Remember to pick up after your dog. The building entrance and the Nadin lot are not potty areas. Go to the north end of the building to potty and please, please pick up. Garbage cans are located outside for your use.
- Owners are responsible for crate outbursts/continuous distracting noise by their dogs and will be asked to monitor their dogs closely or move them to wait in a vehicle. Please familiarize yourself with the new 2018 CKC rules regarding canine behavior at event sites.
- Be sure you have made yourself familiar with the new CKC rules regarding performance classes. Please be patient, as the trial officials work with these rules.
