### The following Regular CKC Classes (divided by sex) will be offered

<u>JUNIOR PUPPY CLASS</u> - This class shall be for any dog 6 months of age and under 9 months of age on the day of the show

<u>SENIOR PUPPY CLASS</u> - This class shall be for any dog **9** months of age and under 12 months of age on the day of the show

<u>12 to 18 MONTH CLASS</u> - This class shall be for any dog **12 months of age** and under 18 months of age on the day of the show

#### **OBEDIENCE CLASSES**

NO DOG MAY BE ENTERED IN BOTH NOVICE "A" & NOVICE "B" AT THE SAME TRIAL NO DOG MAY BE ENTERED IN BOTH OPEN "A" & OPEN "B" AT THE SAME TRIAL

**NOVICE "A"** - This class is open to all dogs, providing the dog has not earned the title of "CD" in ANY COUNTRY. One dog ONLY may be entered in this class by any one exhibitor. The exhibitor MUST BE THE OWNER or A MEMBER OF HIS/HER **IMMEDIATE FAMILY** and **MUST SHOW THE DOG IN ALL EXERCISES**. No licensed handler, trainer or any person who has previously exhibited a dog through its "UD" title in Canada or Elsewhere shall be allowed to compete in this class, but MUST COMPETE IN THE NOVICE "B" CLASS

NOVICE "B" - This class is open to all dogs which have not earned the title of "CD", and may be shown by the owner or any other person. The dog may not necessarily be CKC or ERN Reg'd to compete in this class

OPEN "A" - This class is open to all dogs which have earned the title of "CD" IN CANADA, but have not earned the title of "CDX" in any country. One dog ONLY may be entered in this class by any one exhibitor. The exhibitor MUST BE THE OWNER or A MEMBER OF HIS/HER IMMEDIATE FAMILY and MUST SHOW THE DOG IN ALL **EXERCISES.** No licensed handler, trainer or any person who has previously exhibited a dog through its "UD" title in Canada or Elsewhere shall be allowed to compete, but MUST COMPETE IN THE OPEN "B" CLASS. A CKC or ERN Reg'd number must be provided on the entry form at time of closing of entries to be eligible to compete in this class

OPEN "B" - This class is open to all dogs which have earned the title of "CD" in CANADA, and may be shown by the owner or any other person. This dog MAY ALSO COMPETE IN THE UTILITY CLASS. A CKC or ERN Reg'd number must be provided on the entry form at time of closing of entries to be eligible to compete in this class

UTILITY CLASS 'A' - This class is open to any dog of any recognized or listed breed which has earned the title of "CDX" but has not earned the title of U.D. Any person who has trained or exhibited a dog that has earned a M.O.T.Ch title may not handle dogs in this class. This dog must be shown by the owner or a member of their immediate families. A CKC or ERN Reg'd number must be provided on the entry form at time of closing of entries to be eligible to compete in this class. Owners may enter More than one dog in this class. The same person must handle the dog in all exercises. When a dog is wrongfully entered in this class, any score will be cancelled.

UTILITY CLASS 'B' - This class is open to any dog of any recognized or listed breed which has earned the title of "CDX" or U.D. Dogs in this class may be handled by the owner or any other person. A CKC or ERN Reg'd number must be provided on the entry form at time of closing of entries to be eligible to compete in this class. Owners may enter more than one dog in this class. The same person must handle the dog in all exercises. No dog may be entered in both the Utility A and Utility B classes at any one trial. Prior to the start of judging, the judge will decide the order of exercises to be performed. This order will not be disclosed to exhibitors until it is posted at ringside, approx. 30 mins. Prior to the start of the class.

PLEASE NOTE: The word 'trainer' means any person who conducts or has conducted a dog obedience training class or who regularly assists with the training of dogs in said class or who regularly trains dogs belonging to any person outside his/her immediate family

NOTE: Miscellaneous breeds entered in Obedience Trials that DO NOT have a Certification Number MAY ONLY COMPETE AT THE NOVICE level and MUST pay the Listing Fee applicable on a daily basis

### TRANSITION OBEDIENCE CLASSES

**PRE-NOVICE** - This class shall be for all purebred dogs and those breeds as designated on the list of miscellaneous breeds and of either sex, which have not earned the title of P.C.D. (Pre-Companion Dog) in Canada. Dogs being entered in this class may be handled or exhibited by the owner or any other person. A person may enter more than one dog in this class and must have an additional handler for each dog when they are judged together on the Group exercise. A dog may be entered in the Pre-Novice that has not earned the title of C.D. in Canada or a comparable title in any other country. The Pre-Novice class is an elective class and earning a title is not a requirement to advance to the Novice Classes.

**NOVICE "C"** - This class is open to any dog of either sex that has gained the title Companion Dog, Companion Dog Excellent, Utility Dog or any other advanced Obedience title in Canada prior to the closing date of the trial in which it is to be entered. Exhibitors may enter more than one dog in this class but must have a separate handler for each dog in the Long Sit and the Long Down Exercises when they are judged in the same group. The Novice 'C' exercises will be performed and judged as described in the official Novice Class except that exhibitors may compete in the Novice 'C' Class indefinitely. Scores earned by dogs entered in the Novice 'C' Class are not eligible for High In Trial. The P.C.D. and C.D.I. and Novice 'C' are elective classes which are offered for those people who feel the dog requires ring experience and acclimation to the trial situation or would like to earn additional titles. Dogs may be entered in the Novice – Intermediate (C.D.I.) and/or Novice 'C' class in addition to any of the Official Classes or Unofficial Classes.

**NOVICE INTERMEDIATE CLASS** - This class shall be for all purebred dogs and those breeds as designated on the list of miscellaneous breeds and of either sex, which have earned the title of (C.D.) Companion Dog, Companion Dog Excellent, Utility Dog or any other advanced Obedience title in Canada. A dog eligible for entry in the Open A or B Class at any obedience trial held under these rules is also eligible for entry in the Novice 'C' and Novice Intermediate Class at the same trial. The Novice Intermediate class (C.D.I.) is an elective class and earning a title is not a requirement to advance to a Companion Dog Excellent title. Scores earned by dogs competing in this class are not eligible for High In Trial. Dogs are eligible to compete in this class indefinitely. Dogs in this class may be handled or exhibited by the owner or any other person. A person may enter more than one dog in this class.

**BORDER CROSSING**: Government regulations require that to be brought into Canada a dog must have a Rabies Certificate. The Certificate must be dated 30 days prior to re-entry into the United States.

### SHOW BUILDING HOURS

The building will be open to exhibitors from 6:00 am to one hour after Best in Show on Friday, Saturday and Sunday. The Show Barn (grooming building) will be open from 6:00am to 10:00pm on Friday and Saturday. On Sunday, November 25, the building will open at 6:00am and dogs will be expected to be removed one hour after Best in Show and the building left clean.

1. THE CLUB RESERVES THE RIGHT TO REMOVE ANY PERSON FROM THE SHOW. THE SHOW SUPERINTENDENT SHALL HAVE FULL CONTROL OF THESE SHOWS AND TRIALS, WHICH WILL BE GOVERNED BY CKC RULES.

2. A DOG EXCUSED BY THE SHOW SUPERINTENDENT OR VETERINARIAN FOR ANY REASON SHALL NOT, COMPETE IN ANY CLASS FOR ANY AWARDS FOR BALANCE OF THE SHOW.

3. THE SHOW COMMITTEE WILL USE DUE CARE AND DILIGENCE FOR THE WELFARE OF DOGS AND EXHIBITORS, BUT WILL NOT BE RESPONSIBLE FOR, OR ASSUME ANY LIABILITY IN THE EVENT OF ACCIDENT OR MISFORTUNE TO EITHER DOGS, EXHIBITORS, SPECTATORS OR VENDORS.

4. DOGS MUST BE ON THE GROUNDS 1 HOUR PRIOR TO THE JUDGING OF THEIR BREED. 5. THE OWNER OF A DOG ENTERED IN THESE SHOWS IS ENTIRELY RESPONSIBLE FOR ANY ERROR IN ENTERING HIS/HER DOG REGARDLESS OF HOW OR BY WHOM ENTRY IS MADE

recognized as a Canadian Champion it must: (1) earn at least ten championship points under at least three different judges; (2) a two point win awarded either at the breed or group level; and (3) be individually registered in the records of the CKC or have a CKC Event Registration Number (ERN)

### EXTRACTS FROM CKC DOG SHOW RULES

#### CHAPTER 4.1.3 - JUDGES

A judge officiating at a show held under these rules shall not be subjected to any indignities of any kind during the progress of the show, and it shall be the duty and obligation of the club holding the show to see this rule is effectively enforced.

#### 8 - ENTRIES and ENTRY FEES

#### Section 3.1

Every dog entered in Championship Shows held under these rules must be registered, have an Event Registration Number, eligible for registration with the CKC or have a CKC Miscellaneous Class Certification number issued by the CKC Chief Registrar. If a dog is not registered individually in the CKC it may be entered at a show, held under these rules, as a "listed" dog, provided

- (a) it is not a Miscellaneous breed
- (b) if born in Canada, is eligible for individual registration

(c) if foreign born and owned, an Event Registration Number or CKC registration number is obtained from the CKC within 30 days of the first show entered. A listing fee of \$9.40 must accompany the entry of a "listed" dog at a show held under these rules.

#### Section 2.3:

#### **INCOMPLETE ENTRIES**

Entry forms which are incomplete or those that contain incorrect information after the closing date of entries will be void and under no circumstances can changes be made. Any dog taking a win resulting from such an entry will result in the wins being canceled, and persons making such changes will be subject to disciplinary action.

#### Section 8.2:

#### **DISHONORED CHEQUES**

Tendering of a dishonored cheque or credit card in payment of entry fees shall be considered non-payment of entry fees and is an offense punishable by disciplinary action and cancellation of awards. Clubs may refuse to accept entries from any exhibitors who have been known to tender dishonored cheques in payment of entry fees unless such entries are accompanied by a money order or certified cheque.

#### Section 1.4

#### CHAPTER 14 - DISQUALIFICATION

A dog once disqualified for any reason at a Championship show held under these rules cannot again be shown or entered at a show held under these rules unless and until said dog has been reinstated by the CKC. All awards earned by a dog shown in violation of this section will be canceled by the CKC and the owner of said dog is subject to disciplinary action. Note: for any further information on reinstatement refer to Chapter 16, Section 3 of the CKC Dog Show Rules

#### CHAPTER 9 - EXHIBITORS and THEIR DOGS

A show-giving club will be held responsible during the show for the conduct of exhibitors and spectators. Any person acting in an abusive or objectionable manner must be removed from the show on complaint to the Show Superintendent.
