\* **TEMPORARY COMPETITION NUMBER** (EFFECTIVE MARCH 2, 2020) A Temporary Competition Number (TCN) must be obtained before submitting an entry for an event. The same TCN must be used for all event entries for a dog until the dog is permanently registered. Once a dog is permanently registered or has an ERN, the TCN will be replaced with the registration number or ERN. A TCN cannot be used for Listed Breeds (MCN) or dogs that will require a Performance Event Number (PEN) or Canine Companion Number (CCN). There is no fee to obtain a TCN however exhibitors will still be required to pay TCN Fees when entering events using a TCN. TCN Numbers may be obtained online via the CKC website where the number is issued instantly. Exhibitors may also mail in a printed application or contact CKC Shows and Trials by phone for a number. If your dog does not have a registration number or ERN and has already competed in a CKC event and earned points, scores or awards, before applying for a TCN online, exhibitors are encouraged to check their dog's profiles to determine if the CKC has already created a TCN for that dog. There will be a tab called TCN Dogs in the owner's Portal account.

***NOTE: Separate entry forms are required for each class entered.***  
***ALSO: The CKC's Covid-19 Rules prohibit move-ups or "day of" entries.***

\* Please note that a service charge of 10% will be assessed for entries sent online, by fax or any entry using a credit card or Interac for payment.

**Canadian Residents, please note:** The CKC has implemented an annual "non-member participation fee" for residents of Canada who are not members of the CKC. Check with the CKC for the current fee. The non-member participation fee is paid in any year a title is earned and covers all titles earned and dogs owned by that individual. In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.

The fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

## General Information

1. **It is the responsibility of the exhibitor to be familiar with the rules.** [CKC rules are posted on the CKC website](#) or copies of the Obedience and Rally Obedience Trials Regulations & Standards may be purchased from the CKC. Only certain sections of the rules are highlighted under General Information, so they should not be considered to be complete.
2. Pinch/prong collars are not permitted on the trial site.
3. BITCHES IN SEASON - Refund of entry will be made for bitches who come into season after entries close. Request in writing must be submitted to Trial Secretary with certificate from a veterinarian prior to commencement of the Trial.
4. CONTAGIOUS DISEASE - Refund of entry (less CKC fee) will be made for dogs that are under a veterinarian's care for contagious disease diagnosed after entries close. Request in writing must be submitted to Trial Secretary along with a letter from a veterinarian on or before the day of the Trial.
5. CKC Obedience rules state that "A judge officiating at a trial held under these rules shall not be subjected to indignities of any kind during the progress of the trial. It shall be the duty and obligation of the club holding the trial to see that this rule is effectively carried out."
6. CKC Rally Obedience rules state that "It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer or competitor at a Rally Obedience Trial held under these regulations is not subject to indignities of any kind. The Rally Obedience Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred."
7. If entering a dog in either Obedience [Novice Intermediate, Open or Utility], or Rally Obedience [Rally Advanced, Excellent or Master Classes], PLEASE INDICATE JUMP HEIGHTS on entry forms.
8. Please refer to the current rule book for eligibility requirements for each Obedience and Rally Obedience class. It is your responsibility to ensure that your dog is entered in the correct class.
9. Exhibitors must abide by any errors made in entering their dogs, regardless of how or who made the errors.
10. The precincts of the trials will include the entire interior of the building.
11. Only dogs entered in the trials will be allowed within the precincts of the trials (see #10).
12. Judging schedules and any other pertinent information will be distributed to exhibitors after entries close.
13. All dogs that are foreign born and owned who enter Canada for the sole purpose of entering CKC events will require an Event Registration Number (ERN). An ERN must be obtained within 30 days of earning points, awards or scores to avoid cancellation. If factors beyond your control prohibit this or present a problem, please send a written request for a 30-day extension to the CKC. An ERN may be obtained by contacting the CKC.
14. The Club and the Trial Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability, in the event of accident or other misfortune to dogs, exhibitors or patrons. Neither the Club nor the Trial Committee will be responsible for dogs or property at the trial site.
15. If, because of riot, civil disturbance or other acts beyond the control of the Club, it is impossible to open or complete the Trial, no refund of entries will be made.

## **Additional Guidelines for River Valley Obedience & Field Trial Club's 2021 Trials**

We respectfully request that if you cannot or will not comply with these guidelines, Do Not Enter or Attend.

As of the date of publication of this premium list (August 19, 2021), the New Brunswick borders are open to anyone living in Canada. Please see the following link for current and complete details on travel information: <https://www2.gnb.ca/content/gnb/en/corporate/promo/covid-19/travel.html> **This could change prior to our closing date; it is your responsibility to check.** If it becomes necessary to cancel this event due to changes in provincial guidelines brought on by an increase in the incidence of positive COVID-19 cases, all entry fees will be refunded, with the exception of service fees charged by DogShow.ca . Please monitor the link supplied above for the most recent information on travel.

**THERE WILL BE A ZERO TOLERANCE POLICY ON VIOLATIONS OF THESE COVID-19 GUIDELINES, INCLUDING NOT WEARING A MASK OR NOT SOCIAL DISTANCING WHEN REQUIRED.** Masks will be required to be worn when entering the building, but exhibitors MAY have the option to remove their mask while **INSIDE THE RING ONLY**. Masks will also be required anywhere on the property where social distancing (2 meters) cannot be maintained. Social Distancing is Mandatory in the rings, adjacent ring areas, and at the Secretary's table.

The ring will have a separate Entrance and Exit. Exhibitors shall follow guidance from the Ring Steward .

The trials are NOT open to the General Public. Our Event Waiver must be signed by anyone attending this event: Club Members, Judges, Ring Stewards, Exhibitors, Volunteers, Family Members, Friends etc. Contact tracing information (name & phone number) must be provided for all who attend / enter the precincts of the trials.

Trial Site Access Process: The waiver will be emailed along with the judging schedule; you will be required to print off enough waivers so that every individual traveling with you has their own waiver. The waiver(s) must be handed in to the club upon arrival at our site; an attendance arm band will be provided at this time. It is recommended that each group provides a cell phone contact number upon entering that will be in use during the show. We will have an individual monitoring the ring and notifying exhibitors of possible delays.

The Club will provide a hand sanitizing station and there will be a limited supply of masks available. We do request that you strive to be self-sufficient: bring sanitizer and personal use masks. Do not leave personal belongings at ringside. Please do not leave masks, gloves, water bottles, litter, etc. behind, dispose of these items in garbage bins or take them away with you. Avoid shaking hands, hugging, or other physical contact. Avoid touching dogs that are not your responsibility. Avoid common use pens/pencils – bring your own writing instrument.

OUR EVENT WILL HAVE A STEWARD WHO WILL BE RESPONSIBLE FOR MONITORING PROTOCOL VIOLATIONS. IF YOU OBSERVE ACTIVITY WHICH CAUSES YOU CONCERN, PLEASE REPORT IT IMMEDIATELY TO THE STEWARD; OUR COMMITTEE WILL MAKE A JUDGEMENT AND TAKE ANY NECESSARY ACTION. WE TAKE THIS VERY SERIOUSLY AND WANT TO ENSURE THE SAFETY OF EVERYONE ATTENDING OUR EVENTS AS WELL AS THE PEOPLE IN THE COMMUNITIES TO WHICH THEY WILL BE RETURNING. WE ALSO RECOGNIZE OUR RESPONSIBILITY TO THE DOG SHOW COMMUNITY TO AVOID ANY PERCEIVED OR ACTUAL VIOLATIONS TO THE PUBLIC HEALTH PROTOCOLS PUT IN PLACE BY OUR PROVINCIAL GOVERNMENT\*, SO THAT SIMILAR EVENTS CAN CONTINUE.
