CKC RULE 4.6.1 – INDIGNITIES TO A JUDGE

14.7 It shall be the duty and obligation of the test-giving club to see that a judge, club official, steward, volunteer or any participant at an event held under these rules, is not subject to indignities of any kind. The Tracking Test Committee Chair shall promptly report to the CKC any infringement of this regulation and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.

FAILURE TO PICK UP AFTER YOUR DOG OR ALLOWING IT TO URINATE ON THE TRIAL PRECINCTS OUTSIDE OF THE DESIGNATED AREA, INCLUDING THE BUILDING, STEPS, RAILS, ETC. WILL RESULT IN DISMISSAL FROM THE TRIALS.

Please be responsible for your dog always. For the safety of all dogs and exhibitors we ask that you keep a diligent eye on your dog. Outside the ring we ask that you keep your dog in a crate or on a short leash and under control. Please see the final page of this premium list for CKC Rules and Page 2 for Temporary COVID-19 Rule Changes.

COVID-19 Information (subject to change)

1. All Province of Saskatchewan Health Authority (SHA) regulations will be followed; social distancing and mandatory mask.
2. If you are exhibiting any symptoms of COVID-19, please do not attend the trials.
3. Any handler unable to attend these trials due to exhibiting COVID-19 symptoms after entries close, will receive a credit to any future CKC event hosted by the Wascana Dog Obedience. Credits will expire after 1 year.
4. Masks are mandatory at all times; entering the building, for the briefing, all walk throughs, in the ring and at the dog area east side of the building.
5. Only exhibitors entered in the Class in session will be allowed in the building during that class.
6. Non-compliance without a medical exemption will result in being asked to leave for the protection of all. No refunds will be issued to anyone refusing to comply with public health orders.

The following allowable temporary COVID changes to the Obedience rules and regulations will be followed:

- The handler will place their leash etc., in a designated spot and pick it up at the end of their run.
A ring steward will not bring your leash to you. Your dog must leave the ring on leash and under control.
- Ribbons and score sheets will be left on a table for handlers to pick up if they wish at the end of their class. There will be no ribbon presentation in the ring.
- There will be no printed catalogues. Electronic copies can be emailed.

Rally Obedience Trial Rules

6.5.2 -When a bitch comes into season after entries have closed, the trial giving club must refund the entry fee and listing fee providing the trial secretary receives, on or before the start of the trial entered, a veterinarian's certificate declaring that the bitch was in season within the 10-day period preceding the trial.

6.7.6-A dog that bites or attempts to bite another dog or a person outside the ring may be removed from the trial by the Trial Committee Chair.

20.7 - It shall be the duty and obligation of the trial giving club to see that a judge, club official, ring steward, volunteer, or competitor at an Obedience Trial held under these regulations, is not subject to indignities of any kind. The Obedience Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it seems fit on receipt of a report indicating that this has occurred.

- 1- The Obedience Trial Chairperson is in complete charge of the trial
- 2- No dog will be allowed in the building or on the grounds unless entered in the trials.
- 3- No dog is to be left off leash at any time on or near the grounds of the trial except in the obedience ring. Violations of this rule can result in dismissal from competition. No refund shall be made.
- 4- Exhibitor must wear the correct armband while in the ring.

General Instructions

- 1- No dog will be allowed to compete unless entry fees have been paid in full.
- 2- Refunds will not be made after the closing date for dogs that do not compete unless under section 6.5.2 of the Obedience Trial Rules and Regulations.
- 3- The Trial Committee has the right to refuse any entry subject to CKC rules.
- 4- The Club will use due care and diligence for the welfare of the dogs and exhibitors, but will not be responsible for, or assume any liability in the event of an accident or other misfortune, either to dogs, exhibitors or patrons.
- 5 -A judge officiating at the trial under Obedience Trial Regulations and Standards shall not be subject to indignities of any kind during the progress of the trial. It shall be the duty of the club holding the show to see that this rule is effectively carried out. The Trial Chairman shall promptly report to the CKC any infringement of the rule. The Board of Directors shall have the power to take action as it deems fit on the receipt of a report indicating this rule has been violated.
- 6 - If because of a riot, civil disturbance or other acts beyond the control of the trial giving club, it is impossible to open or to complete the trials, no refund of entries will be made.
- 7 - Fees must accompany your entries. Tendering a NSF cheque shall be considered an offense punishable by disciplinary action and cancellation of awards by the Canadian Kennel Club. There will be a \$25.00 fee charged for any NSF cheque issued. No post-dated cheques will be accepted . Over payments will be donated to the club trophy fund.
