#### **Directions to Trial Site:**

From Deerfoot Trail, take 16<sup>th</sup> Ave. East. Turn left (north) at the first set of traffic lights, onto 19<sup>th</sup> St. NE, then turn right (east) at the the lights, onto 18<sup>th</sup> Ave. NE. We are located on the east side of the Furniture Mart, on your right hand side.

#### **Entries Open December 1, 2011**

#### **Entry Closing Date March 5, 2012**

Entries must be received by the trial secretary no later than midnight March 5, 2012.

Mailed, couriered, telephoned, emailed and fax entries will be accepted as long as a signed General Agreement is provided as an original prior to the trial start time. Please make checks payable to Sit Happens! Any changes to entries (handlers, etc.), will be accepted up to March 5, 2012. Changes made are final and will not be altered. Changes must be made to the Trial Secretary by telephone, email, or in writing. Move-ups will be allowed between trials both in Level and in Class. Team runs are limited to 80 runs per day.

Cancellations received after March 1, 2012 will not be eligible for a refund of any portion of paid fees.

#### Weather

This trial will be held indoors at our heated facility on a rubber matted surface, so weather will only be a factor in case of severe traveling conditions making getting to and from the facility too dangerous. In case of **severe** weather (eg. tornado or heavy heavy snow) we will reschedule the trial at a later date.

#### **Crating and Food**

There will be limited space available for benching dogs inside the facility. Water is available.

There are several restaurants and fast food outlets within a short driving distance of Sit Happens! for handlers.

#### Check-In

Doors will open and check-in will begin at 700am daily. First walk-through and Judge's briefing will begin at 800am. Subsequent walk-throughs and briefings will take place as each round ends and the next course is set. There will be a one hour lunch break at approximately 1200 pm each day.

#### A and B Classes and Judges Class

A classes are for teams that have not yet completed their title at that level.

B classes are for teams that have already completed their title at that level.

The Judges class will be run prior to the commencement of each level the judge is entered in.



#### **Awards**

Qualifying ribbons will be awarded to each dog/owner team who achieves a score of 170 or better. Placement ribbons (first to fifth) will be awarded to A - Level competitors ("A" dogs do not yet have a title at that particular level).

At end of each day, awards will be given to the High Scoring Team in each Level (separate awards for A & B Level). At the end of the weekend, awards will be given to High Scoring Team in Trial (separate awards for A & B Level) as well as other special awards.

### **Notice to Competitors**

Competitors, through submission of entry, acknowledge that they are knowledgeable of APDT Rally Obedience rules and regulations including but not limited to the following rules regarding entry:

- This trial is open to <u>all dogs</u> being at least six months of age, including purebred and non-purebred, except bitches in season or dogs with disabilities, injuries or illnesses which may cause the dog pain or great discomfort, or dogs exhibiting signs of aggression that threaten the safety of other dogs or humans as determined by the Judge or APDT Rally Rep.
- All dogs must be registered with APDT Rally prior to competing. A one-time registration form is available and must be submitted DIRECTLY to the Rally-O Coordinator (NOT to trial hosting organization) before the date that a team first submits an entry in a sanctioned trial. See <a href="https://www.apdt.com/rally/register">www.apdt.com/rally/register</a>.
- Dogs must be shown by a member of the owner's immediate family: mother, father, spouse, life partner, sibling, child, grandparent, or grandchild.
- Safety shall always be of foremost consideration in actions and conduct by handlers at all times. Handlers, through entry at this event, accept full responsibility for themselves and the actions of their dogs.
- The organizing committee may refuse any entry for any reason.

#### In addition.

- THERE SHALL BE NO REFUND for entries withdrawn after March 1, 2012
- , or in the event a dog and/or handler are dismissed from competition, regardless of reason for such dismissal. There will be no refunds if the trial has to be cancelled for any reason.
- Returned checks do not constitute a valid entry. There will be a \$25.00 service charge for returned checks. Payment of entry fees and service charges shall be made in cash or money order within 30 days of postmark of notice of returned check. Any unpaid fees or shortfalls must be paid prior to the start of the event or entry is canceled without recourse by owner/handler. Where notification is received after event date, any fees not received within 30 days of notice result in cancellation of event results for all classes for the registration number(s) of delinquent entry/entries. No reinstatement of results is possible, and all awards must be returned within 10 days of notification, or the dog's registration may be suspended pending restitution.
- No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, Act of God, public emergency, act of a public enemy, strike or any other cause beyond the control of the organizers.
- All dogs shall be shown in a flat buckle collar, plain harness, or properly fitted martingale (limited slip) collar. No choke collars, prong collars, shock collars, no-pull harnesses, martingale leads, head collars, or collars not named as "allowed" will be permitted.
- All competitors through entry at this event waive any and all rights relative to video broadcast of this event. Competitors shall have
  the right to videotape portions of this event for their personal use only. No portion of this event may be videotaped for commercial or
  other purposes. All video, broadcast, and telecast rights for this event are the exclusive property of the APDT or Sit Happens!<sup>®</sup>
  Companion Dog Training.
- Owners with disabilities are encouraged to compete. Any necessary modifications to the exercises must be provided by the handler to the judge and approved by the judge.
- Dogs with disabilities are encouraged to compete provided that the dog does not show evidence of being in pain or discomfort as
  determined by the judge.
- Upon successful completion of an exercise, the owner may choose to briefly pet or touch the dog as a reward or choose to give the dog food as a reward. Food may NOT be used as a lure to help the dog complete an exercise. Food rewards must be contained in pockets or hidden treat pouches and only be present in the owner's hand in between exercises. Any petting, touching, or feeding that significantly interrupts the flow of performance shall be scored accordingly.
- Exhibitors may use food as a reward in the ring upon completion of any Stationary exercise.
- Dogs must remain under control at all times while on trial site grounds. Dogs must remain on leash at all times unless crated, or performing off leash exercises in the ring, while on trial site grounds. Day kenneling only is permitted. Limited benching space is available inside the facility.
- Please pick up after your dog and yourself.

# GENERAL AGREEMENT

I (we) agree that Sit Happens!® Companion Dog Training has the right to refuse this entry for any cause which the organizing committee alone shall deem to be sufficient. In consideration of the acceptance of this entry, of the holding of the event, and of the opportunity to have the dog participate and/or to be judged, I (we) agree to hold the organizing committee, the hosting club, the Association of Pet Dog Trainers, including their members, officers, directors, agents and employees, sponsors of the event, and owners of the premises upon which the event is held and their employees, harmless from any claim for loss or injury that may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim. I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, appearance, theft, damage, or injury be caused or alleged to be caused by the negligence of the parties aforementioned, or by the negligence of any other person, or any other cause or causes. Further, I (we) hereby grant to the Association of Pet Dog Trainers, Sit Happens!<sup>®</sup> Companion Dog Training, their representatives, agents, and assigns, all rights and permissions to use or appropriate my and the dog's name, biography, likeness, photograph, voice, performing persona, or other indicia or identity for broadcast, telecast, cablecast, transmission, or distribution in any format or media now known or hereafter to become known. I (we) hereby release APDT, the hosting club, their representatives, agents, and assigns from any claim or cause of action for invasion of the rights of privacy, right of personality, or any similar right.
