## GENERAL AGREEMENT

I (we) agree that the Canadian Association of Rally Obedience (CARO) and Kayenna Kennels (host organization / venue) have the right to refuse this entry for any cause which the organizing committee alone shall deem to be sufficient. In consideration of the acceptance of this entry, of the holding of the round, and of the opportunity to have the dog participate and/or to be judged, I (we) agree to hold the organizing committee, CARO, and Kayenna Kennels including their members, officers, directors, agents, and employees, sponsors of the round, and owners of the premises upon which the round is held and their employees, harmless from any claim for loss or injury that may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the round premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for such claim. I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, appearance, theft, damage, or injury be caused or alleged to be caused by the negligence of the parties aforementioned, or by the negligence of any other person, or any other cause or causes. I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death resulting at any time therefore sustained by any person or persons, including myself (ourselves), or on account of damage to property arising out of or in consequence of my (our) participation in this round, howsoever such injuries, death, or damage to property may be caused, and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.

I (we) further acknowledge that I (we) have read, understand and will abide by the Official Rules and Regulations of the Canadian Association of Rally Obedience and the provisions for entry as set forth in the Rally Test Schedule of which this entry form is part. I (we) acknowledge and represent that the information supplied by me (us) herein is correct to the best of my (our) knowledge; if any portion of this information is found to be invalid or insufficient to establish the validity of my (our) entry, such finding shall render my (our) entry invalid in its entirety, for which there shall be no refund of fees paid.
