Best Veteran in Breed, Group & in Show – must be entered in the Veteran class to compete – Sunday, May 18th only!

OUR JUDGES

Patricia Taylor - My favorite breeds of all time are Longhaired Dachshunds – both Miniature and Standard. I have bred them for over 35 years, and took on the challenge of breeding and showing the daple pattern on the many colours the Dachshund offers. I was raised on a mixed farm in Southern Manitoba, so I have enjoyed a variety of animals all my life – especially horses and dogs. I have been judging at dog shows since 1991. I now judge all CKC groups. My experience with other breeds include: English Setter, Doberman, Chow Chow, Bull Mastiff, German Shepherd, Sheltie, Golden Retriever, Nova Scotia Duck Tollers, and Scottish Terriers.

In my real life I wrote commercials for local radio stations in Brandon, MB for 20 years, plus other jobs dealing with the general public for approx. 15 years. I wrote a variety of columns for a daily newspaper, dog publications and gardening magazines over the years.

Richard Fehler - During his working career Rick was Production Manager of the Regina Leader-Post, a large daily newspaper in Regina, Saskatchewan, Canada. Rick retired in 2009.

Rick and Carman purchased their first Doberman Pinscher in 1968 and started breeding under the SONDOU prefix in 1974. In the early eighties they added their first Bichon Frise. Rick has bred and owned many Champion Doberman Pinschers and Bichon Frises.

Rick now owns two Champion Australian Shepherds. He also co-owns a Doberman and a Toy Manchester Terrier. Rick first began to attend shows involved in obedience. With the purchase of his first Doberman bitch he soon moved to the Conformation side. He also handled dogs for friends and clients. Most of these dogs were German Shepherds, Boxers, Golden Retrievers and Flatcoat Retrievers. From there it seemed a natural progression to move into judging. Rick became an All-Breed judge in 2002.

Lucie Paradis - I was born in Quebec City, and have been competing all my youth in synchronized swimming (Bronze Medal in team competition in Japan at the World Championship in 1970). I also competed in hunter and equitation classes, starting to compete at 7 years of age, and I still compete in the hunter ring. I have a son 32 years old and 2 beautiful granddaughters. I graduated from veterinary school in Montreal in 1977 and I have a busy small animal practice. I purchased my first Corgi in 1978 from Rosalie Harvie (Polruan) who became my mentor. I bred English Cocker Spaniels, and of Whippets. I own Corgis and Whippets, under Joska Perm Reg'd. I have competed in obedience, rally and conformation.

I began judging in 2000, I am licensed for 4 groups and completing my 5th group permit (Terriers).

Ben Wasylyshen - Manitoba artist / design consultant, Ben Wasylyshen works in varied media including: glass; steel; watercolor and photography. His work is seen in art collections including the Province of Manitoba, Canadian Museum of History and the State Museum of Art in Kyiv.

In the field of purebred dogs, Ben began in 1973 with terriers and made a shift to toys with a focus on the Italian Greyhound breed, where he has been devoted for over 30 years!

As a former lecturer/critic at Manitoba's Architecture Faculty, he now turns his attention to Dog Show judging and is honored to be invited to Regina to judge Toys this weekend.

Richard Meen – Involved in the dog show world since 1970. He bred under the Klshniga Reg. prefix. He has owned and shown Borzoi, French Bull Dogs, Skye Terriers, Italian Greyhounds, Old English Sheepdogs, Dobermans, Harriers, Scottish Deerhounds, American Foxhounds, Greyhounds, Lakeland Terriers and Standard Poodles. Richard Meen has been judging since 1997.

Wendy Maisey - Wendy Maisey is the CKC Director for AB/NWT/NU. She resides in Calgary, Alberta, Canada with her husband, several Cavaliers and one Berger Picard. Originally in Dobermans, she got her first Doberman in 1972 and over the next 35 years produced many champions, BIS and BISS winners that set records for the breed, as well as some outstanding performance dogs. She also bred Miniature Pinschers in the 80's that are behind some of the most successful kennels today.

For the last ten plus years she has bred Cavalier King Charles Spaniels with a strong focus on the whole colors that have also set records within this breed including the first whole color to win the Canadian National Specialty. Now retired from a demanding career in Project Management, she is very active in Agility with her Cavaliers being ranked at the top in their breed in several organizations including the first Cavalier to get an Agility Master Championship. She is also the Chair of the CKC Agility Council.

Wendy began judging conformation in 1999 and is approved for 6 groups (Sporting, Working, Toys, Herding, Non Sporting and Terriers) and provisional for Hounds.

Lynda Berar - My involvement in purebred dogs started in the early '60s with a Samoyed that I did obedience with. In 1967 I got my first Miniature Schnauzer. She was to be my obedience competition dog and turned out to be far and above any expectations I had! She obtained numerous HIT with her best score coming from the open class at eight years of age – 199 ½!! I was truly enamored with the breed and started to show in conformation. Since then I have finished almost 200 Canadian Champions owner/handled from my kennel. I have had numerous BIS dogs, numerous dogs that have placed in the top three of my breed and numerous record holders.

During the group judging on Sunday, May 18th our judges will address the audience describing the purpose of the breeds that they are judging, the essential qualities of that breed, what qualities they are looking for and the thoughts behind their selections. CHAMPIONS AND CHAMPIONSHIP POINTS

A dog awarded WINNERS at a Championship show shall be credited with a number of championship points (ranging from 0 to 5) and the number of championship points credited to a dog awarded WINNERS shall be as provided hereunder. The schedule to be employed in the determination of the number of points awarded WINNERS shall be as follows:

Competing*	1	2	3-5	6-9	10-12	13 or more
Points	0	1	2	3	4	5

*Includes the dog awarded Winners

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall NOT be included in the calculation for points. If a dog awarded WINNERS is also awarded BEST OF BREED at the show, then all dogs competing in the breed, including Specials Only, shall be included in the total. If a dog awarded WINNERS is also awarded BEST OF OPPOSITE SEX to Best of Breed, then all dogs of the same sex including those competing for Specials Only shall be included in the total. If a dog is awarded WINNERS is also awarded BEST OF WINNERS, then all dogs defeated directly or indirectly in the breed shall be included in the total. If a dog is awarded WINNERS only, then all the dogs of the same sex in the class competition shall be included the total. The number of championship points to be credited to a dog awarded WINNERS shall be determined by the highest award earned and calculated as per Section 15.1. In addition to championship points allocated at the breed level, a dog awarded WINNERS, which also places in the regular Group competition, shall be credited with the following additional points provided that a dog was defeated at the Group level.

A dog awarded WINNERS which also places BEST IN SHOW at an All-Breed Championship Show shall be credited with 5 Championship points inclusive of any points earned at the breed and group level. In no case can a dog earn more than five points at a single show.

An error in the class, date of birth or sex may be amended on the entry form up to one hour BEFORE the start of the show.

SHOW RULES AND GENERAL INFORMATION

1. Showing correct information on entry forms is the responsibility of the entrant. The show committee reserves the right to refuse any entry subject to CKC rules. Entry forms must be the same size and format as those included or they will be rejected.
2. No entry will be accepted unless accompanied by entry fees. Telephone entries WILL NOT be accepted. Email and Fax entries will be accepted. See instructions elsewhere in this premium list.
3. Post-dated cheques ARE NOT accepted. Tendering of an N.S.F. cheque or credit card in payment of entry fees shall be considered non-payment of entry fees and is an offense punishable by disciplinary action and cancellation of awards. **A \$25.00 SERVICE CHARGE WILL BE LEVIED ON ALL N.S.F. CHEQUES AND INVALID OR DECLINED CREDIT CARDS.**
4. Entry fees WILL NOT be refunded in the event that a dog is absent, sick, lame, excused by the veterinarian or judge, in season or barred from competition because it has been entered incorrectly.
5. Withdrawal of entries prior to closing date may be made by telephone, but **MUST BE FOLLOWED UP IN WRITING** to the Show Secretary so as to be received no more than 7 days after closing.
6. The entry of any dog cannot be altered or canceled after entries close, except as provided in the Dog Show Rules.
7. After the closing of entries, an identification/receipt and judging schedule will be mailed or emailed to each exhibitor or agent. Owners making entries please include agent's address. All online and fax entries will receive a conformation email, this is your receipt for our shows. Please print your email address clearly.
8. **ALL DOGS MUST BE KEPT UNDER CONTROL AT ALL TIMES.**
9. The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for or assume any liability in the event of an accident or other misfortune to either dog, exhibitor or patron. The Show Giving Club will not be liable for any loss or injury that may be sustained through the disappearance, loss, theft, and/or death of dogs entered in the show under any circumstances.
10. If, because of riot, civil disturbance or other acts beyond the control of the management, it is impossible to open or to complete the show, no refund of entry fees will be made.
11. EXHIBITORS PLEASE NOTE: Chapter 24, Section 6, C.K.C. Dog Show Rules states "Any person participating in any capacity at a dog show held under these Rules shall not be subjected to indignity of any kind during the progress of the show and it shall be the duty and the obligation of the Club holding the show to see that this rule is effectively carried out."
12. **ACCORDING TO CITY BYLAW, DOGS ARE NOT ALLOWED OFF LEAD WITHIN CITY LIMITS. Exercise dogs only in designated areas. Anyone not following stop and scoop policy will be excused from the shows and trials.**
