Note: Online entry and payment is payment is NOT a guarantee of entry. AFTER the closing date, confirmations will be sent out to those whose entries have been accepted; along with a note to anyone who was over the limit, who will have the option of being put on a randomized wait list, or being immediately refunded. All entries not accepted will be refunded.

ELIGIBILITY

To be eligible to compete in these trials a dog must be 6 months of age or older and have a CKC Registration number (CKC), Event Registration Number (ERN), Performance Event Number (PEN), Canine Companion Number (CCN), Miscellaneous Certificate Number (MCN) or a Temporary Competition Number (TCN). TCN's replace the previous system of entering events with dogs as "listed" and will allow dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN). If needed, a TCN MUST be obtained from the CKC prior to entering any CKC event ([click here](#) for instructions).

RALLY TRIAL RULES AND REGULATIONS

Chapter 19 – Section 19.7 of the Obedience Rules and Regulations states: It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at an Obedience Trial held under these regulations, is not subject to indignities of any kind. The Obedience Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

6.5.2 Bitches in Season are not permitted to compete. When a bitch comes into season after entry of the bitch has been submitted to the trial secretary, a veterinarian's certificate, certifying that the bitch was in season within the 10 day period preceding the trial, must be submitted to the trial secretary on or before the date of the trial. All fees will be refunded.

NON-MEMBER PARTICIPATION FEE

Effective January 1, 2011:

- A non-member participation fee will be charged to a resident of Canada who is a non-member of the CKC.
- The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.
- In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.
- The fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.
