

### **NEW RE-ENTRY REQUIREMENTS TO THE US**

On **June 1, 2009**, the U.S. government will implement the full requirements of the land and sea phase of WHTI. The proposed rules require most U.S. citizens entering the United States at sea or land ports of entry to have a **passport, passport card,** or other travel documents approved by the Department of Homeland Security.

**BORDER CROSSING**: A Rabies Certificate is required to bring a dog into Canada. Government regulations require this certificate MUST be dated at least 30 days prior to re-entry into the U.S.

RAMPS: Effective January 1, 2010, a ramp must be available to judges (at their discretion) for examination of low heavy set breeds, in accordance with the CKC Rules and Regulations: Spaniels (Clumber, Sussex,), Basset Hounds, Whippet, Bull Terriers (miniature), Irish Terrier, Kerry Blue Terrier, Soft Coated Wheaten Terrier, Staffordshire Bull Terrier, Bulldog, Chinese Char-Pei, Chow Chow, Keeshound, Polish Lowland Sheepdog

## **ENTRY INFORMATION**

- 1. No entry will be accepted unless all particulars called for on the entry form are completed in full. Handlers or agents please note the full name and address of all owners must be filled in.
- 2. Incomplete entries will be returned. No entry will be accepted unless accompanied by entry fees. Telephone and telegraph entries cannot be accepted. Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made.
- 3. There is no refund for duplicate cheques. Every effort will be made to find all duplicate entries, however if the entry has been processed and appears in the official catalogue, no refund will be made.
- 4. Substitutions or cancellations of any entry after the closing date is prohibited. Moving Class Dogs to Specials is permitted. An error in the class, date of birth or sex may be amended on the entry form up to one hour before the start of the show. Only dogs which are already registered in the Canadian Kennel Club Stud Book, or are eligible for such registration can be entered. The committee reserves the right to refuse any entry subject to CKC Rules.
- 5. Entries positively close 12 noon. (PDT) Thursday July 4, 2013, and must be in the hands of the Show Secretary by that date.
- 6. There is no refund for duplicate entries. Every effort will be made to find all duplicate entries, however if an entry has been processed and appears in the official catalogue, no refund will be made.
- 7. Identification cards and judging schedules will be emailed as soon as possible after the entries close. Identification cards must be presented upon arrival at the show.
- 8. Tendering of NSF cheques in payment of fees shall be considered non-payment of fees and is punishable by disciplinary action. Any N.S.F. or returned item will be subject to a minimum \$50.00 service charge.

- 2. The Club reserves the right to decline to accept entries for just cause, in which case the fee will be refunded with the reason for non-acceptance. No one shall have any claim or recourse against the Club holding the show or any official connected therewith for refusal of an entry.
- 3. The Show-giving Club will exercise due care and diligence for the welfare of the dogs and exhibitors, but will not be responsible for, or assume any liability in the event of an accident, or other misfortune, to either dogs, exhibitors or patrons.
- 4. Exhibitors are solely responsible for the conduct of their animals while they are on the Show Grounds. Exhibitors are responsible for their equipment and possessions. Equipment will **not** be left on the show grounds overnight.
- Dogs must be ready for judging. The club will not be responsible for and not obligated to provide any service for notifying owners or agent of breed or class judging. NO RING WILL BE HELD UP WAITING FOR EXHIBITORS OR HANDLERS.
- 6. For the benefit of the health of animals, the pleasure of exhibitors and spectators we insist upon keeping the show grounds as clean as possible. EXHIBITORS ARE RESPONSIBLE FOR CLEANING UP AFTER THEIR DOGS. Dogs are to be exercised in DESIGNATED AREAS ONLY. Failure to comply may result in future entries being refused.
- 7. All trailers, motor homes, campers and recreational units will have buckets underneath their sink drains. Anyone found discharging gray or black water from their unit will immediately be removed from the grounds.
- 8. There will be no other facilities in case of inclement weather.
- 9. If, because of riot, civil disturbance or other acts beyond the control of the Club, it is impossible to open or complete the show, no refund of entry will be made.

### **Sweepstakes**

### Saturday—Lunch Break—Judge Doug Savory

All dogs six (6) months and under eighteen (18) months of age shall be eligible to compete

All dogs must be entered in one of the regular Breed classes

The classes in the Sweepstakes are divided by sex and offered as follows:

Junior Puppy 6 months and less than 9 months
Senior Puppy 9 months and less than 12 months
12-15 Months 12 months and less than 15 months
15-18 Months 15 months and less than 18 months

For final judging, the first place dog from each of the above classes will be brought together for the final placing of "Best in Sweepstakes" and "Runner-Up to Best in Sweepstakes"

### **PRIZES**

Best in Sweepstakes will be awarded 25% of the Entry Fees received and a Rosette

Runner-Up to Best in Sweepstakes will be awarded 20% of the Entry Fees received and a Rosette

First Place winners in each class 3.75% of total entry and a Rosette 2nd to 4th place in each class—Flat Ribbon

The Club will retain the remaining 25% to defray costs.

# Non Member Participation Fee

An annual non-member participation fee for awards and titles will be charged to a <u>Canadian</u> non-member of CKC. The fee will match the ERN fee.

In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.

**These** fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.

### Points for Best in Show

A class dog awarded Best in Show at an all-breed Championship show will be credited with 5points inclusive of any points earned at the breed or group level. In counting the number of eligible dogs in competition, a dog that is disqualified or that is dismissed, excused or ordered from the ring by the judge, shall **NOT** be included in the calculation for championship points (effective January 1, 2012) (Absentees are not to be included). In order for a dog to be recognized as a Canadian Champion it must: (1) earn at least ten championship points under at least three different judges; and (2) be individually registered in the records of the CKC or have a CKC Event Registration Number (ERN)

Canadian Bred— For dogs born in Canada. Champions in any country excluded

**Bred by Exhibitor**—For a dog owned and handled in the ring by the breeder/co-breeder. Family members ARE excluded

Open—Shall be for all dogs.

Specials Only—Dogs which have a recorded CKC Registration number or Event Registration number and have attained the required points for championship status. Dogs entered in this class will compete for Best of Breed, Best of Opposite Sex, and Best Puppy if eliqible.

NON-REGULAR CLASSES

**Exhibition Only**—Dogs entered in this class may not compete in any of the Regular Classes

# **Champions and Championship Points**

SECTION #1. A dog awarded WINNERS at a Championship show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5),and the determination of the number of championship points to be credited to a dog awarded WINNERS shall be as provided hereunder. SECTION #2. The schedule to be employed in the determination of the number of points to be allocated a dog awarded Winners shall be as follows:

A dog awarded WINNERS at a Championship show shall be credited with a number of championship points (ranging from 0 to 5) the number of championship points shall be as follows:

Dogs competing\* 1 2 3-5 6-9 10-12 13 or more Points allocated 0 1 2 3 4 5 \*Includes the dog awarded Winners.

In addition to championship points allocated at the breed level, a dog awarded WINNERS which also places in the regular Group competition shall be credited with the following additional points provided that a dog was defeated at the group level.
