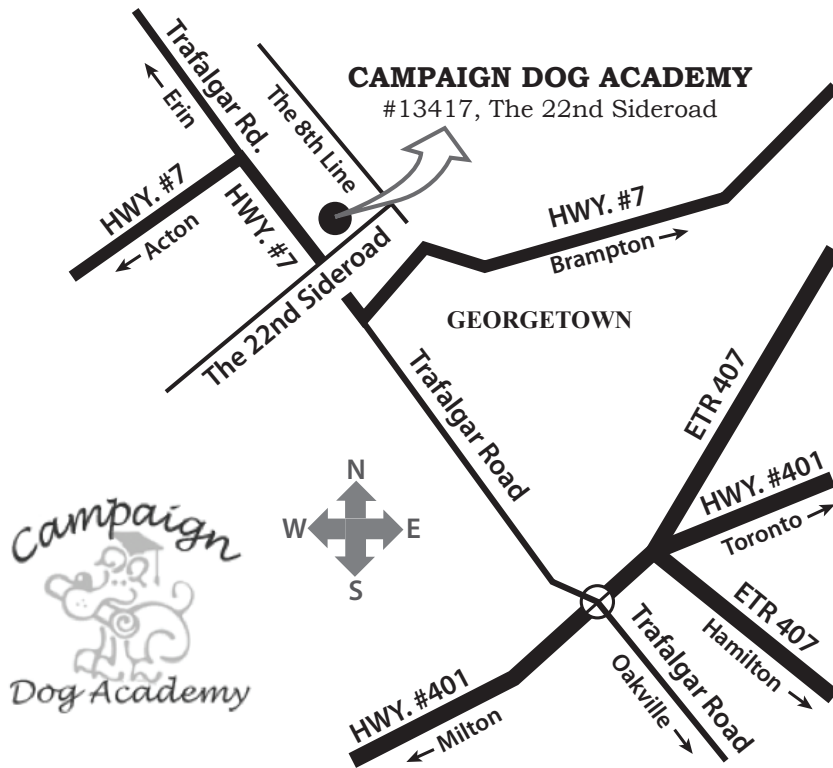


MAP

Effective January 1, 2011:

- An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will be \$57.60 plus applicable taxes.
- In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
- These fees apply only to dogs wholly owned by non-CKC members and are **not applicable to CKC members.**

**EVENT REGISTRATION NUMBER (ERN)**

Effective Jan. 1/92, all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC registration number but will require an Event Registration Number (ERN). The ERN number MUST be applied for within 30 days of the first day of entering a CKC event. **Fee is \$57.60 per dog.**

## IMPORTANT NOTICE TO OBEDIENCE EXHIBITORS

There is no limitation on the number of trials at which a dog may be entered as a 'listed dog', except that a dog which has obtained three qualifying scores at obedience trials held under C.K.C. rules, may not continue to compete at licensed obedience trials held under the Club's rules until the dog is registered individually with the C.K.C. Foreign born and owned dogs, please refer to Event Registration Number (ERN) information listed elsewhere.

A dog which has won a comparable degree in any foreign country is not eligible for entry in the Novice A class but may be entered in the Novice B class if it has not earned its C.D. degree in Canada. A dog which has won its C.D. degree in Bermuda or the U.S. or has won a comparable degree in a foreign country, may be entered in the Novice B class if it has not earned its C.D. degree in Canada.

A dog which has won its C.D.X. degree in Bermuda or the U.S. or has won a comparable degree in any foreign country, is not eligible for entry in the Open A class but may be entered in the Open B class.

### NOVICE A CLASS:

One dog only may be entered in this class by any one exhibitor.

### OPEN A CLASS:

One dog only may be entered in this class by any one exhibitor.

### NOTE:

A dog entered in either of these classes must be handled in the ring by the owner or a member of his/her immediate family.

### PRE-NOVICE CLASS:

For any dog that has not earned the title PCD (Pre Companion Dog) title in Canada. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class and must have an additional handler for each dog when they are judged together in group exercise. A dog may be entered in this class that has not earned the title of CD in Canada or US.

Dogs in obedience must wear a well-fitted plain buckle or slip collar. Slip collars of any appropriate single length of leather, fabric or chain with two rings, one at each end, are acceptable. There shall be nothing hanging from the collar.

## IMPORTANT NOTICE TO RALLY OBEDIENCE EXHIBITORS

There is no limitation on the number of trials at which a dog may be entered as a 'listed dog', except that a dog which has obtained three qualifying scores at obedience trials held under C.K.C. rules, may not continue to compete at licensed obedience trials held under the Club's rules until the dog is registered individually with the C.K.C.

## ENTRY INFORMATION

1. No entry will be accepted unless all particulars called for on the entry form are completed in full. Handlers or agents please note the full name and address of all owners must be filled in.
2. Incomplete entries will be returned. No entry will be accepted unless accompanied by entry fees. Telephone and telegraph entries cannot be accepted. Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made.
3. There is no refund for duplicate cheques. Every effort will be made to find all duplicate entries, however if the entry has been processed and appears in the official catalogue, no refund will be made.
4. Substitutions or cancellations of any entry after the closing date is prohibited. An error in the class, date of birth or sex may be amended on the entry form up to one hour before the start of the trial. Only dogs which are already registered in the Canadian Kennel Club Stud Book, or are eligible for such registration can be entered. A dog may not enter the Open or Utility class unless it is registered with the CKC. The committee reserves the right to refuse any entry subject to CKC Rules.
5. **ENTRIES POSITIVELY CLOSE 8:00 P.M. (EST) FRIDAY, MAY 20, 2011** or when the limit for each trial is reached and must be in the hands of the Show Secretary by that date.
6. **LIMITED ENTRY:** Entry in each Obedience trial will be limited to the capacity of the judge to perform 7 hours of judging at the rate of 8 Novice dogs per hour, 7 Open dogs per hour and 6 Utility dogs per hour. Once a judge has reached their maximum capacity, the entries shall be closed but a reserve list will be created. Handlers will be notified of their position on the reserve list. Any entries pulled after closing date due to a bitch coming in season, their spot may be filled by a competitor on the reserve list, up to and including the day of the trial.
7. Identification cards and judging schedules will be mailed as soon as possible after the entries close.
8. Tendering of NSF cheques in payment of fees shall be considered non-payment of fees and is punishable by disciplinary action. Any N.S.F. cheques will be subject to the current fees charged by the LOC's financial institution.

## GENERAL INFORMATION

1. The Trial Superintendent will be in full charge of the show which will be governed by CKC Rules.
2. The Labrador Owners Club will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume liability in the event of accident, or other misfortunes, to either dogs, exhibitors or patrons. A dog shall not be touched without permission of the owner or agent.
3. If, because of riot, civil disturbance or other acts beyond the control of management, it is impossible to open or to complete the trial, no refund of entry will be made.
4. **TRIAL PRECINCTS:** The trial precincts shall consist of all judging areas set aside for the trial officials, judges, exhibitors and handlers and thirty (30) feet outside of the rings.

Prizes will be awarded for:

Highest Qualifying Score in each Trial  
Highest Qualifying Score for a Labrador in each Trial  
Highest Qualifying Scoring Veteran Dog in each Trial (7 years of age or over)  
Highest Qualifying Scoring Champion with a Working Title  
Highest Qualifying Scoring Labrador with a Tracking Title

A rosette will be given to any dog completing their title.

## OBEDIENCE TRIAL RULES AND REGULATIONS

The Exhibitor is responsible for knowing and complying with the Obedience Rules and Regulations of the Canadian Kennel Club.

**Chapter 19 - Section 19.7** of the Obedience Rules and Regulations states: It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at an Obedience Trial held under these regulations, is not subject to indignities of any kind. The Obedience Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

## RALLY OBEDIENCE TRIAL RULES AND REGULATIONS

The Exhibitor is responsible for knowing and complying with the Rally Obedience Rules and Regulations of the Canadian Kennel Club.

**Chapter 17 - Section 17.7** of the Rally Obedience Rules and Regulations states: It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer or competitor at a rally Obedience Trial held under these regulations, is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
