**\*Temporary Competition Fee (Listing Fee):** As established by the CKC a fee of \$10.50 must accompany the entry of a dog for which a CKC individual registration number or Event Registration Number (ERN) is not shown on the entry form. ### **Entries & Payment:**

- Entries close: 6 PM Thursday, September 30, 2020.
- All entries must be sent to the Test Secretary. Entries will be accepted **by mail only**, with one entry per envelope. Payment must accompany each entry.
- Only one entry will be accepted for each dog.
- Receipt of entries will be acknowledged by e-mail. Please contact the Test Secretary if an acknowledgement is not received in a reasonable time after mailing your entry.
- Make cheques or money orders payable to North Okanagan Tracking Club.
- U.S. entrants may pay by money order payable in Canadian funds or personal cheque in U.S. funds for the full amount of the fees.
- Post-dated cheques will not be accepted.
- There will be a \$50.00 service charge on all **NSF** cheques received. Tendering an NSF cheque shall be considered non-payment of entry fees and is an offense punishable by disciplinary action and cancellation of awards by the CKC.

**Refunds:** When an entered dog is withdrawn after the closing date, refunds will only be permitted when the vacancy is accepted by an "alternate". Out of consideration for other entrants, if you are unable to participate in the test, please notify the test secretary as soon as possible.

Alternates will be contacted in catalogue order and advised of the opening. They may choose to accept the spot and become responsible for the entry fee or decline and bear no financial obligation. Anyone on the alternate list may request a refund at any time prior to test day. Entries will be refunded within 10 days of the test date to those on the alternate list that did not participate in the test.

**Prizes:** Rosettes will be awarded to successful competitors.

**Entry Draw:** A random draw, which is public, will take place at **4:30 PM Friday, October 1, 2021** at Brookside Stables, 6621 Okanagan Ave NE Salmon Arm, BC. The entry draw will follow the procedure as outlined per rule 2.2.4. Following the draw, entrants will be notified by email as to their position in the test or on an alternate list.

**Club Worker Draw:** A worker draw will be conducted in accordance with 6.6.2 of the regulations if sufficient entries are received, two (2) TD tracks will be reserved for club workers.

**Bitches in Season:** Bitches in season may compete, but will run last (rule 6.7.1). Please inform the Secretary **immediately** upon arrival at the meeting place.

**Meeting Place & Draw for Tracks:** All participants will rendezvous at the A & W at 3130 Smith Drive in Armstrong, BC for the drawing of tracks. Turn off Highway 97B at the traffic light. Go 1 block and turn left at the stop sign. The A & W is visible from the highway.

Draw will take place at **8:00 AM Sunday**. Any primary entrant who is not present at this time will forfeit their position to the first alternate present. Competitors will convoy to the location of the test and the first track will be run as soon as it is sufficiently aged.

**No Host Luncheon:** Location and time to be announced at the Draw on the morning of the test.

**Liability & Safety:** In attending this test, all competitors and guests acknowledge that they do so at their own risk and that of their dog. They also agree not to hold liable the CKC, North Okanagan Tracking Club or its test officials, the judge or the land owners for any loss, damage or injury, however arising, to themselves, their dog or their chattels. All reasonable care will be taken for the safety of dogs, handlers and spectators. Please use caution alongside roads and be aware of farm equipment.

**Covid-19:** This test will be conducted in accordance with applicable Covid-19 requirements.

**Indignities:** (Rule 14.7) "It shall be the duty of the test-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules, is not subject to indignities of any kind. The Tracking Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred."

**Note to non-members of the Canadian Kennel Club – Non-Member Participation Fee:** A participation fee will be charged to a resident of Canada who is not a member of the CKC. The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual. In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level. This applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.
