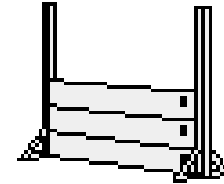

Failure to comply within thirty (30) days of notification will result in the title being withheld and the dog cannot be moved up. For a membership application, please go to www.ckc.ca under CKC Services and Form on-line. The Non-Member Participation Fee is fee paid in the calendar year (January—December) in which the dog achieved its title.

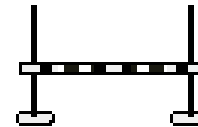

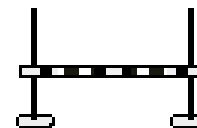

The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. (See Section 26.7)

SHOW PRECINCTS: The Show precincts shall consist of all areas set out for rings, all shelters or facilities set aside for show officials, judges or exhibitors and handlers, and an area of 30 feet outside of the judging rings.
