

Entries will not be acknowledged by return mail or phone.


Entries may be acknowledged by email if the owner forwards an email address.

Ribbons or rossettes will be offered for all placements:

First=blue, Second=red, Third=yellow, Fourth=white, NBQ=green.

Highest scoring Single=navy/gold.

Best of Breed= purple/gold.



NORTHERN AZAWAKH ASSOCIATION

Eligible Breeds and Registry:

Only pure bred Afghan Hounds, Azawakh, Basenjis, Borzoi, Cirneco del Etna, Greyhounds, Ibizan Hounds, Irish wolfhounds, Italian Greyhounds, Pharoah Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Silken Windhounds and Whippets may be entered in the "Singles" Stake.

All non-sighthound breeds, mixed breeds and Sighthound crosses are eligible for the LCI stakes. Purebred sighthounds may enter the Regular Singles stake only except Azawakh and Silken Windhounds may enter their Regular breed stake.

All Azawakh, Silken Windhounds and Singles entries shall be individually registered with the AKC (ILP, PAL included), the UKC, the FCI, an ASFA recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBs. A photocopy of acceptable registry must be submitted with each hound/dog's first ASFA field trial entry.

REGULAR STAKES OFFERED: (AZAWAKH, SILKEN WINDHOUNDS, SINGLES & LCI).

Open Stake: Any eligible Sighthound, excluding ASFA Field Champions of record, that has met the certification process.

Field Champion Stake: Any ASFA Field Champion.

Veteran Stake: Any eligible hound that has met the certification process who's age is at least 6yrs. Points go toward V-FCH or V-LCM titles.

Singles Stake: Any eligible sighthound including those disqualified from running in other stakes. Each hound runs alone. Not eligible to run for Best of Breed or Best in Field, hounds are eligible to earn TCP and CPX titles from the Singles stake. Provisional breeds are not eligible for these titles.

Conditions of entry: All hounds/dogs must be at least one year of age on the day of the trial. Bitches in season and lame hounds/dogs will be excused at roll call. Spayed, neutered, monorchid, cryptorchid hounds without breed disqualifications may be entered. Hounds with breed disqualifications may be entered in the Singles stake. Hounds/dogs not present at the time of roll call will be scratched All hounds/dogs will run twice in trios or braces (if possible), except in the Singles and LCI stakes, unless excused, dismissed or disqualified.

Best in Field will NOT be offered.

LURE CHASING INSTINCT STAKES:

Open to non-sighthounds, mixed breeds and Sighthound mixes.

Entry forms for LCI are on page 9 of this document. Requests for ASFA Unique entry Number forms are on page 10.

Lure Chasing Instinct Program: All dogs entered must have a registration number via one of the following: A. AKC/CKC registration as one of the recognized breeds. B. CKC (CCN), AKC Canine Partners which is for mixed breed dogs or dogs ineligible for AKC/CKC registration. C. Purebred Alternative Listing (PAL) which is for purebred dogs that cannot be fully registered with AKC to participate in AKC events. D. Foundation Stock Service (FSS) which is for recorded breeds on the road to full AKC recognition. E. United Kennel Club (UKC) as one of the recognized breeds. If the dog has none of the above registrations, ASFA will provide a unique and permanent registration number for a one time fee of \$10. 1. The owner must complete a request for a ASFA request for unique entry number. 2. The trial secretary will submit a copy of the form with the trial records. 3. The owner will retain a copy as proof of request and payment until a permanent number is provided.

Small Open: dogs 17.5" or less at the withers, and/or brachycephalic (flat faced) dogs who have not achieved the title of LCC.

Small Senior: dogs 17.5" or less at the withers and/or brachyscephalic dogs that have achieved the title of LCC.

Small Veteran: dogs 17.5" or less at the withers and/or brachycephalic dogs that are 7yrs or older.

Large Open: dogs over 17.5" at the withers who have not achieved the title of LCC.

Large Senior: dogs over 17.5" at the withers who have achieved the title of LCC.

Large Veteran: dogs over 17.5" at the withers that are 7yrs or older.

Sighthound Mixed Open: for dogs with a Sighthound breed in it's background that has not achieved the title of LCC.

Sighthound Mixed Senior: for dogs with a sighthound breed in it's background that has achieved the title of LCC.

Sighthound Mixed Veteran: for dogs with a sighthound breed in it's background that is 7yrs or older.

When running as a stake in a regular trial, "Small" will run 50% of the ASFA course as laid out for the sighthound breeds, to a maximum of 400yds. All other stakes will run the full ASFA laid out course length.

EQUIPMENT: Type of lure machine: Gas powered continuous loop system.

Type of lures: Highly visible white plastic strips. Back up equipment will be available.
