Introducing Our Judges

BARBARA ARNDT

Growing up, my family always had dogs and in 1972 I purchased my first Afghan Hound. Since then, I have never been without this beautiful breed sharing my home and my life. I have also owned and shown Salukis and right now I own a Standard Long Hair Dachshund that I have shown in the United States and Canada.

As a breeder, owner and handler I have had the privilege of producing and finishing many Canadian and American Champions. Dogs of my breeding have many specialty and group wins in both Canada and the United States and have proven to be multi-talented in lure coursing, obedience and agility. I am extremely proud to say that a bitch of my breeding went on to be the Number 2 Agility Afghan in the United States in 2009. At the Eukanuba Invitational in Long Beach, California she finished as number one Agility Afghan Hound.

In 2004 I was fortunate to retire early from my career as a Director of Human Resources. This gave me the opportunity to pursue judging. I am licensed to judge all of the breeds in the Hound Group, the Sporting Group, Terrier Group and ½ of the Herding Group. I have judged Hound Group Specialties, Sighthound Group Specialties as well as individual specialties for Afghan Hounds, Basenjis, Deerhounds, Greyhounds, Ibizan Hounds, Pharaoh Hounds and Whippets. I have judged specialties in Canada, the United States, Australia, Italy, Denmark, Slovakia, Sweden and South Africa. I have also had the privilege of judging at all breed shows from Coast to Coast in Canada, the United States, Australia, Italy, Sweden, Slovakia and South Africa. I have given presentations on The Afghan Hound in Canada at specialty shows in Canada and Italy.

My club involvement includes being a long time member of the Canadian Kennel Club, the Afghan Hound Club of Canada, and being active in 2 all-breed Kennel Clubs. Presently I am the Past President of the Afghan Hound Club of Canada and have held Executive positions with this club for many years as well as being Show Chairman for 3 National Specialty Shows. I am also the Secretary of the Seaway Kennel Club and Past President of the Wine Country Kennel Club.

I love judging and enjoy the opportunity to see beautiful dogs and meet wonderful people whenever possible. I am excited to judge at your show. *(Barbara Arndt is also judging the Alberta Lure Coursing Association Specialty at this show)*

KIMBERLY MEREDITH-CAVANNA

I have been involved in the sport of purebred dogs since 1972. A breeder-exhibitor of Alaskan Malamutes, I have bred over 60 champions, in a limited breeding program; including multiple all breed Best In Show winners as well as multiple National Specialty winners. I owner handled the youngest Working Group winner in the history of the breed, a record that still stands to this day.

I purchased my first show Doberman 17 years ago. I have had one Doberman litter that are 18 months old, with one Champion and more on the way. In addition to exhibiting Alaskan Malamutes and Dobermans, I have owned and exhibited Akitas, Bernese Mtn. Dogs, Lhasa Apsos, a Clumber Spaniel and a Whippet.

I am currently approved to judge Best In Show, Jr. Showmanship, the Working, Sporting, Herding, Hound and Non Sporting groups. I have judged abroad in France, Italy, Spain, Holland, Belgium, New Zealand, Germany, Finland, Denmark, Japan, China, S. Korea and Australia. I have judged National specialties for Akitas, Alaskan Malamutes, Portuguese Water Dogs, Siberian Husky, Newfoundlands, Golden Retriever, and Border Collies. I have been honored with judging the Westminster Kennel Club seven times including judging the Working Group in 2010. In 2016 I judged the National Dog show on Thanksgiving Day and the Working group at the AKC/Royal Canine show in Orlando. My husband Barry and I share our homes with two Alaskan Malamutes, two Dobermans and a Border Collie. *(Kimberly Meredith-Cavanna is also judging the Alberta Doberman Pinscher Club Specialty at this show)*

LANA FERGUSON

My involvement in purebred dogs began in 1979. My first show dog was a Dalmatian, CH Aiglons Pixie CD. In our very first show Pixie went BPIG and, as they say, the rest is history. I was hooked. Going forward I spent many years showing Dalmatians in both the conformation and obedience rings. During those years I occasionally handled Shetland Sheepdogs for my mother who was very involved in obedience.

In 1999 I purchased my first Doberman Pinscher BIS CH Devonquest Misdemeanor CD, CGC (Devon). Dobermans have been my passion since Devon entered my life and I have been committed to the breed ever since.

Over the years I have bred Dalmatians and Dobermans under the Legendale prefix. I currently am active in conformation, nosework, obedience, lurecoursing as well as barn hunt. I am a Life Time member of CKC, member of DPCA and DPCC.

I am a licenced Mortgage Broker and have owned my own business Verico Vistabay Mortgages Inc., for many years. I am an avid curler and enjoy golfing when time permits.

This is an exciting time for me as I begin embarking on my judging career.

JIM HAM

Jim Ham purchased a \$100 pet Dalmatian in 1972. That very special bitch became the first Am/Can CH, Am/Can UDT in the breed. Jim has also bred, trained and exhibited other Dalmatians, Smooth Fox Terriers and, his present breed, Border Terriers.

Jim now judges about sixty dog shows each year. When not judging, he often shows his Border Terrier in agility, obedience and rally.

Jim is a retired elementary physical education teacher and former swimming and tennis coach. He enjoys sailing and tennis. *(Mr. Ham is also judging the Rottweiler Club of Canada National Specialty obedience and rally trials as well as conformation at this show.)*

GORDON HAYBURN

I moved, from the UK to Canada in February 2011, having been involved in dog showing activities at various levels for many years including committee member of the English Setter Society of Scotland and Golden Retriever Club of Wales. I was also the Secretary of the English Setter Society of Wales and the Chairman of the Irish Red and White Setter Club of Great Britain. I have owned and shown the following breeds: English Setter, Irish Red & White Setter, Labrador Retriever and Golden Retriever. I award Challenge Certificates in the UK and am approved by both CKC and AKC to judge the Sporting Group and the Hound Group. I am on permit for the top half of the Working Group.

Barbara Heal began her canine career in 1969 breeding Samoyeds under the "Polobar prefix while living in Truro, Nova Scotia. During that time she became one of the Founding Members of the Cobequid Kennel Club. She is a Life Member of the Canadian Kennel Club, Past President of the Ottawa Kennel Club and served as Show Chair for the Purina Invitational Show of Shows for 9 years in addition to the Eukanuba Best of the Best 100. Barbara also served as President of the Samoyed Club of Canada on two separate occasions and wrote the Samoyed Breedlines column in Dogs In Canada magazine for eight years. She is also currently an active contributor to the Canadian Dog Fancier Magazine. Other activities also include serving as a member of the CKC Discipline Committee from 2000 to 2003 and most recently serves as Coordinator on the CKC Judge's Observation Program.

Barbara's interest in the Doberman Pinscher began in 1980 after joining her late husband Fred with his "Jagermeister" Dobermans. She is an active member of the Canadian Dog Judges Association and is currently serving as Vice President. In addition to judging across North America; Barbara has judged in Australia, Brazil, Finland and Korea.

ANNA HEWSON

There has been a dog in my life for the past 50+ years. Since being encouraged to pursue a judging career I have enjoyed the journey learning along the way with a lot of reading and help from some of the best of both breeders and exhibitors taking multiple handling classes, courses and enjoying countless hours of discussions, gleaned what I could from a number of wonderful people of different breeds over the last 25+ years. Many people. I've owned a Rough Collie, an Irish Setter, which I sent out on a handler; a Newfoundland, a Portuguese Water Dog and a Pointer that I showed. My journey of breeding and exhibiting began with Siberian Huskies.

After moving to the farm I dove 'total immersion' into my husband's breeding/show operation of Clydesdale horses; at any one time there were 35 to 45 Clydes on the farm. We showed our Clydesdales throughout Southern Ontario including the Royal Agricultural Winter Fair in Toronto both 'on the line' in conformation and in multiple hitch classes. There was a Hewson Clyde in every Royal from inception until 2004.

I fell in love with the Australian Shepherd and they became my breed continuing under the ThundeRun prefix. I enjoyed success with my breeding program obtaining many Championships on dogs I've bred, both Sibes and Aussies, as well as others I've had the pleasure to own along the way. I've dabbled in some performance events with my Aussies, mostly in my backyard, although I do have a few CGN, HIC and RN titled dogs; plus multiple agility titled Aussies owned and handled by others. No longer breeding, I have recently taken on an Irish Setter to show.

I have had the pleasure of judging many lovely exhibits across Canada, eastern U.S. and Australian Shepherd of America shows in the U.S. The fun continues!

GINA LOFFREDO

I was 12 years old when I started in the dog game in 1964 with a little terrier mix named "SCOOT" that my father brought home. This special little dog earned his Canadian UD equivalent at Fun Matches.

I have given obedience classes since 1965 and have had my own small school for decades.

In 1970 I bought my first Shetland Sheepdog - "KUDOS" - Ch. & O.T. Ch. Summit's Kaliph of Kudos Can. Am. Bda. UD - 200 scorer - High in Trials - Dog World Award winner. In 1979 I bought my first Sheltie female "FANCY" and shortly afterwards obtained "SARAH" my foundation bitch from Jean D. Shelties and Obedience is my passion.

MARK LUCAS

My name is **Mark Lucas** of Lumberton, North Carolina. I began exhibiting dogs in 4-H when I was 12-years-old and became involved with showing Shetland Sheepdogs and Collies. I was hooked! I bought my first Italian Greyhound a few years later - he and I enjoyed becoming a multi-group winning team. His name was Ch. Uwharrie's Solar Flare, and he was the foundation male to my breeding program. Since my beginnings over 28 years ago, I have bred many champions including Specialty, National specialty, and Best In Show winners.

I have been judging since the late 1990's, and I am approved to judge the Toy Group, Shetland Sheepdogs, Collies, Australian Shepherds, Poodles, Xoloitzcuintli, French Bulldogs, Whippets, and most recently been approved to judge Best In Show. I am in the process of applying for more breeds in the non-sporting group. I have had the honor of judging the Italian Greyhound National Specialty as well as several regional specialties in many of my approved breeds. *(Mr. Lucas is also judging the Shetland Sheepdog Fanciers Specialty at this show)*

MARY NAPPER

I am very honored to have been asked to judge at the Northern Alberta Canine Association all breed show.

I started in the sport of dogs in 1975 in Kalamazoo, Michigan with an Old English Sheepdog and a great mentor. I have also owned & exhibited Cocker Spaniels, Chinese Cresteds, Komondors, Afghans, and Miniature Pinschers and have handled a few other breeds.

With limited breeding I have had two Winners Dog at a Cocker Spaniel National Specialty/Flushing Spaniel Show, one being also awarded BOV in Futurity. A third of my breeding also accomplishing Winners at a National Specialty going on to being a multiple Best in Show winner.

I started judging in 2007 and I have had the great honor to judge the American Spaniel Club's Cocker Spaniel National Specialty. I am a life member of American Spaniel Club and have served six years on the board of directors, President of the Cocker Spaniel Specialty Club of Dallas, member of the American Chinese Crested Club and Dallas Miniature Pinscher Club. I also am a member of the DFW Judges Association where our main focus is breed education.

I believe in giving each dog my full attention and consideration, as they are entitled to my honest and unbiased opinion.

I currently have several cocker spaniels and one Italian Greyhound. I am approved to judge Best In Show, Toy Group, Miscellaneous Breeds, 13 Sporting Breeds and all breed Junior Showmanship competition. *(Mary Napper is also judging the American Cocker Spaniel Club of Canada Specialty at this show.)*

LEW OLSON

I started in the sport of dog shows in 1974 in obedience, and conformation in 1975. I saw my first Rottweiler at the Chicago International show in 1977 and I knew I had to have one. There were very few breeders at that time, and it was a task to find one! I got my first Rottweiler puppy in 1978, who later became Ch Rodsens Berte Von Zederwald CDX. I have been active in this breed for 40 years and I have bred over 100 champions. I have continued to do obedience with my dogs, and my husband Jeff Shaver has put numerous tracking titles on them.

Six years ago I got my first Brussels Griffon, and I have been actively showing this breed, as well as doing rally and obedience. I won Best of Breed at the World Show in 2017 with my Smooth Brussels Griffon, truly a high light of my years in showing dogs.

I started judging in 2003, and I currently judge the Working and Toy group, and the Non-Sporting group. I have also judged in Finland, the Czech Republic, Estonia, Jamaica and Trinidad.

I have written a book on Canine Nutrition, called "Raw and Natural Nutrition for Dogs", and I enjoy researching any and all topics about canine health issues and genetics. *(Lew Olson is also judging the Rottweiler Club of Canada National Specialty at this show)*

EUGENE PHOA

I commenced judging in the early 1970's. I was first licensed to judge English Cocker, followed by several gundog breeds, at open show level by the Singapore Kennel Club, and then at championship show level by that Club over an increasing number of breeds and eventually on an all-breeds basis. Over the years until I immigrated to Canada, I judged a few shows in the general South-East Asia region at championship show level. I immigrated to Canada in 1976 and, after a few years, was licensed as an all-breeds championship show judge by the Canadian Kennel Club.

I have judged in various countries around the world, including shows at Championship Show level in the Singapore, Malaysia, the Philippines, Japan, Canada, the United States, Australia, New Zealand, Argentina, Uruguay, Peru, Chile, the United Kingdom, Spain and Scandinavia. I have also judged National Specialties of the English Cocker in Canada (several times), the United States (approximately 400 entries), breed specialties of the Boxer (Uruguay), Alaskan Malamute and Siberian Husky (Australia), and large entries of English Cocker breed specialties in the United States, Australia, New Zealand, and the United Kingdom (including the London Cocker Spaniel Club Championship Show in the U.K. in 2015, where I had the honour of an entry of about 300 bitches).

Although I have owned and bred various other breeds (including several Working, Toy and Terrier breeds) in my younger days, I have, since the mid 1960's, concentrated my energies almost exclusively on English Cocker. I came to own my first English Cocker with the purchase in 1959, in Perth, Western Australia, of a red bitch of "Treetops" breeding, and since then, have owned and/or bred many dogs which have earned their championships in Singapore, Malaysia, Canada, the United States, Australia, England, and several other countries.

In between times, I tried to practise law and had the honour of being appointed one of her Majesty's Counsel before I retired from my practice in 2009.

I thank the club or clubs, and their members, for the honour of judging their dogs, and I look forward to doing so.

RICARDO SALDANA

"I am passionate about all breeds of dogs, concentrating on healthy dogs, sound moving dogs of correct type and temperament"...

Born in México City, Ricardo Saldaña Solórzano grew up in a family of dog lovers. At 11 years old, he started participating in Dog Shows as owner-handler. Later he became a Steward for the Federación Canófila Mexicana (Mexican Kennel Club), activity which he performed during many years; in this time he was steward for judges all around the world.

He participated actively as a steward and judge in the 1978, 1984, 1999 and 2007 World Dog Shows in México City. He was member of the Board of the Federación Canófila Mexicana for 20 years. He has represented México in the General Assembly of the FCI meetings in Germany, Switzerland, Argentina, Belgium and México.

At 16 years old, he was judging his first match show. He obtained his first license to judge in 1980 and in 1988 he was credited as judge with international license to judge all breed by the FCM and the FCI. He was judged in more than 40 countries, in many of the most prestigious shows. He has judged in World Dog Shows; Royal Shows in Australia; New Zealand and South Africa Championships; many of the most prestigious shows in USA and Canada; International FCI Shows in Asia, Sudamerica and Europe.

He was President of the School of Judges of the Federación Canófila Mexicana; he has organized and participated in many seminars and conference to prepared new judges.

For 15 years he was President and Show Chairman of the Club Canófilo de Michoacán, in Morelia.

He was owned dogs of various breeds like English Cocker Spaniel, Smooth Fox Terrier, Xoloitzcuintle, Toy Poodles, Pomerania and Smooth Chihuahueño; he has breed Labrador Retriever and American Cocker Spaniel.

But his breed is the Pugs. He has breed Pugs for over 26 years, many of which have become Mexican, International champions and BIS winners. He is co-owner of the "Guivercelli Kennel", along with his wife Gabriela Guillén, breeding many more winning Pugs around the World and the top winning Pugs in México.

He has judged a Pug specialty show in Brazil, New Zealand, Russia and Argentina.

He wrote for a dog show magazine in México, Argentina and USA and is a professional journalist, producer of television and specialist in institutional marketing. *(Mr. Saldana is judging the Pekingese Club of Canada National Specialty and the American Cocker Spaniel National Specialty at this show)*

Glen Stark

Glen's love of purebred dogs began over 50 years ago as a Junior Handler showing German Shepherds owned by his Father. While those dogs were not intended to be "show dogs" Glen persisted and earned Canadian Champion conformation titles on 3 dogs until his junior hockey career took priority.

While playing hockey in Europe in the 1970s Glen chose the Belgian Tervuren, the breed for which he would become known for breeding and handling for the next 25 years under the kennel prefix *Gemfire*. Glen bred and showed over 60 Champions with both American and Canadian titles in both Conformation (and Obedience) winning 45 BIS and 11 BISS.

Throughout the 1980s and 90s Glen was the President and Show Chairman of the Kawartha Kennel & Obedience Club (Ontario) and served as President of the Belgian Sheepdog Club of Canada. Glen has professionally shown many breeds in all seven groups throughout his career including Scottish Terriers, Golden & Labrador Retrievers, Cavaliers and many others. In particular, Glen campaigned several top winning Rottweilers over a span of fifteen years.

In 2014, Glen became the President of the Canadian Shetland Sheepdog Association. He was the Show Chairman for the 2012, 2014 and 2018 CSSA National Specialty shows.

Glen began his Conformation judging career in 2003 and is currently licensed for the Herding, Working, Toys, Sporting, Non-Sporting and Terrier groups. He has enjoyed numerous assignments throughout North America and most recently has been selected to judge Best In Show at the 2019 JKC Kanagawa Minami Clubs Federation show in Tokyo.

Together with his wife Cheryl Pike, they have bred Shetland Sheepdogs under the *MacLaren* prefix and have finished multiple CKC and AKC champions. Glen is dedicated to the sport in many areas not exclusively in Shetland Sheepdogs but also through judging, education, clubs and more. (*Mr. Stark is also judging the Bouvier des Flandres National Specialty and the Toy Dog Club of Alberta Specialty at this show. He is also judging the NACA limited breed show for all Terriers.*)

BETTY WINTHERS

Betty M. Winthers, of Lynnwood, Washington, has been active in the sport for more than 60 years, encompassing a wide range of experience as breeder, exhibitor, trainer, judge, and as an AKC Executive Field Representative of Obedience, Tracking and Rally.

Betty is an AKC Breeder of Merit who has bred and exhibited German Shepherd Dogs with obedience titles ranging from CD, CDX, UD, UDT; a Champion CDX Miniature Poodle, a CDX Papillon as well as many Champion Papillons.

Betty was nominated for the AKC Lifetime Achievement Award in 2011, and is the recipient of the Gaines Sportsman award for the German Shepherd Dog Club of Washington State. She is also the recipient of the D'Ambrisi award from the Association of Obedience Judges. Please see CKC rule books for specific class descriptions. These rules may be viewed on the CKC website (<https://www.ckc.ca/en/Files/Forms/Shows-Trials/Event-Rules-Regulations/Conformation-Show-Rules-and-Regulations.aspx>). It is the responsibility of the exhibitor to be familiar with the Conformation, Obedience & Rally rules as set out by the Canadian Kennel Club

CONFORMATION

The following CKC conformation classes (divided by sex) will be offered:

Junior Puppy: for dogs 6 mths of age but under 9 mths of age.

Senior Puppy: for dogs 9 mths of age but under 12 mths of age

12-18 Months: for dogs 12 mths of age and under 18 mths of age

Canadian Bred: for dogs born in Canada; champions in any country excluded.

Bred by Exhibitor: for dogs owned and handled in the ring by the breeder.

Open: for all dogs.

Specials Only: dogs which are registered individually in the records of the Canadian Kennel Club and have attained championship status may be entered in the 'Specials Only' class. Exhibition Only: for all dogs over 6 mths of age and eligible for registration with the CKC (non-competitive class).

Veterans: offered Saturday only. Veterans will be divided Males and Females with a Best of Breed judged for each. The Best of Breed winner will go on to Best Veteran in Group and Best Veteran in Show. Dogs must be 7 years or older on the day of the show.

Baby Puppy (3-6 Mths): offered Friday, Saturday, Sunday only. For dogs 3 mths of age & under 6 mths of age – dogs will compete in this unofficial class for Best Male/Best Female, Best Baby Puppy in Breed, Group & Show. They do not compete for Winners.

Novice B: for any dog of any recognized or listed breed, mixed breed or unrecognized breed has not won the title of CD. Dogs in this class may be handled by any person. More than one dog may be entered by any handler, but each dog must have a separate handler for the 'sit' and 'down' exercise.

Novice C: for any dog of any recognized or listed breed, mixed breed or unrecognized breed has gained a CD or any higher obedience titles. **Novice**
Novice Intermediate: for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned a CD or higher obedience title. Dogs may compete in the Novice Intermediate class indefinitely. Scores earned by dogs competing in this class are NOT eligible for High in Trial.

Open HA & 18A: for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has won the title of CD but has not won the title of CDX. The handler of any dog in these classes must be the owner, co-owner or a member of their immediate families. Only one dog may be entered in this class by any one exhibitor.

Open HB & 18B: for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has won the title of CD and any dog that has earned the CDX or any higher obedience titles may enter either of the Open B classes. Rally Advanced A: for dogs that have earned the RN title but have not won the Rally Advanced title or any CKC Obedience title other than PCD. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. No handler who has exhibited a dog through its CKC CDX title shall be eligible to enter this class.

Rally Advanced B: for dogs that have earned the RN title. A dog completing the RA title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class.

Rally Excellent A: for dogs that have earned the RA title but have not won the RE title or any CKC Obedience title other than PCD.

Rally Excellent B: for dogs that have earned the RA title. A dog completing the RE title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

Rally Master: for dogs that have earned the RE title. A dog completing the RM title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

In consideration of the acceptance of entries made in these all-breed shows, obedience trials, agility trials or any of the associated Specialties, and of the holding of these shows and of the opportunity to have the dog judged and to win prize money, ribbons or trophies, I (we) agree to hold the Northern Alberta Canine Association and associated Specialty Clubs, their members, directors, governors, officers, agents, superintendents, or show secretaries, and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of a dog while in or upon the show premises or grounds or near any entrance thereto, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of a dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the Club(s) or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in these shows and trials, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused and whether or not the same may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.
