**Change of Entry: Per Section 6.9 in January 1, 2021 rulebook** with following specific additional allowance. A dog that fulfills the requirements for a title in accordance with the rules during the first trial of the day may move-up to a higher level class for the second trial. The change must be on the appropriate move-up form and submitted to the Trial Secretary by the owner or handler 30 minutes before the start of the class.

Schedule is based on entries at time of publication and is subject to change due to late withdrawals/replacements.

## General Information for Exhibitors

In order to make everyone's visit a safe and enjoyable one, The Poodle Farm has a few rules:

- 1. No outdoor shoes allowed on the turf indoors.**  
**Please ensure you bring a clean, dry pair of indoor only shoes.**
- Please do not arrive before 8 am. There will be no admittance to the building before that time.
- Indoor crating is very limited. There is a warm up area inside, however you should be prepared to crate from your vehicle.
- Dogs must be on a leash at all times except when competing in the ring. No "Flexi" lines allowed on the property.
- Please keep your dog under control and out of other dogs 'faces', give other dogs the room they may require.
- Please pick up after your dog's waste. Please pick up after yourself. There are waste containers for your trash.
- Please do your best to keep barking to a minimum.
- No smoking, vaping or Cannabis anywhere on the property.**
- Per CKC rules, only dogs officially entered are permitted within the Trial Precincts.
- Per CKC rule 6.7.3 "There shall be no intensive or abusive training of dogs within the venue of the trial." The "venue" being the entirety of The Poodle Farm property.
- Outdoor shade/shelter tents may be setup on any grassy area in the event of inclement weather.



**No Lunch will be available on site.**  
**Pop and bottled water will be available.**

- Turn right onto Windham Rd. 6 to 2<sup>nd</sup> house on the left
