To be on site dogs must be entered in the trial or Exhibition only

These events are held under the rules of the Canadian Kennel Club, unbenched, unexamined, indoors. To comply with CKC regulations, we will be unable to accept, alter, cancel or substitute any entry reaching the event secretary after the official closing date and time for entries except for as provided in the CKC rules.

**Rally Novice A** - Dogs competing in this class may not have earned the RN title or any CKC Obedience title other than PCD. No handler who has exhibited a dog through its CKC CDX title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or member of their immediate families. A person may enter more than one dog in this class. No dog may be entered in both Rally Novice A and Rally Novice B at any one trial. All exercises are judged on leash and dogs must enter and leave the ring on leash.

**Rally Novice B** - Any dog may compete in this class until a qualifying score in the Rally Advanced class is earned. The owner or any person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged on leash and dogs must enter and leave the ring on leash.

#### **Rally Intermediate Class**

The Rally Intermediate class is an elective class for exhibitors and earning the title is not a requirement to enter Rally Advanced Classes. This class shall be for dogs that have earned the RN title. A dog completing the RI or any other obedience or rally titles may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

**Rally Advanced A** - This class shall be for dogs that have earned the RN title but have not earned the RA title or any CKC Novice Obedience title other than PCD. No handler who has exhibited a dog through its CKC CDX title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner or member of their immediate families. All exercises are judged off leash and dogs must enter and leave ring on leash. A person may enter more than one dog in this class. No dog may be entered in both Rally Advanced A and Rally Advanced B at any one trial.

**Rally Advanced B** - This class shall be for dogs that have won the RN title. A dog completing the RA may continue to compete in this class indefinitely. The owner or any person may handle dogs in this class. All exercises are judged off leash and dogs must enter and leave the ring on leash. A person may enter more than one dog in this class.

**Rally Excellent A** - This class shall be for dogs that have earned the RA title, but have not earned the RE title or any CKC obedience title other than PCD. No handler who has exhibited a dog through its CKC CDX title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner or member of their immediate family. All exercises are judge off leash and the dog must enter and leave the ring on leash. A person may enter more than one dog in this class. No dog may be entered in both Rally Excellent A and Rally Excellent B at any one trial.

**Rally Excellent B** - This class shall be for dogs that have earned the RA title. A dog completing the RE title may continue compete in this class indefinitely. The owner or any person may handle a dog in this class. All exercises are judged off leash and dogs must enter and leave the ring on leash. A person may enter more than one dog in this class.

**Rally Master** - This class will be for dogs that have earned the RE title. A dog completing the RM title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

#### **Rally Obedience Rules & Regulations**

Chapter 20.7: It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Rally Obedience Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report indicating that this has occurred.

**Bitches in Season** are not permitted to compete. The judge of a Rally obedience trial must remove from competition any bitch in season, or any bitch which appears so attractive to males as to be a disturbing element. When a bitch comes into season after entry of the bitch has been submitted to the Trial Secretary and a Veterinarian's certificate that the bitch was in season within the ten day period preceding the trial, the Trial giving club will refund entry, service charges and listing fees.

Any ties in individual classes or for High in Trial will be determined by the judge of that trial in accordance with rules

Eligibility: To be eligible to compete in a Rally Obedience trial, the dog must be registered with the CKC, be eligible for registration with the CKC, have an ERN, or have a CKC Miscellaneous Certificate number or a Canine Companion number. A dog may be spayed, neutered or debarked.
