Dogs may enter the show premises any time prior to judging and leave the show premises when no longer required for judging. The show premises consist of the rings and the 3 metre space around them.

Please know your armband number to pick armbands up before trialing.

Obedience Judging is based on: Utility-6 dogs/hour, Open-7 dogs/hour, Novice A, B, C, Intermediate-8 dogs/hour & Pre-Novice-9 dogs/hour.

Rally Obedience judging is based on 15 dogs/hour plus 10 min walk through time.

General information The precincts of the show will be the show building and its surroundings *All exhibitors will be responsible for the clean up of their own dogs anywhere on the show site and surrounding areas.

Exhibitors are advised to check judge's sheets when posted and to immediately advise of any inaccuracies.

It is the exhibitor's responsibility to know the rules pertaining to show and trials.

2024 Rally rules for handlers

Rally Novice A

9.1.1 Dogs competing in this class may not have earned the RN title or any CKC obedience title other than PCD. No handler who has exhibited a dog through its CKC CDX title or CKC RA title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. A person may enter more than one (1) dog in this class.

11.1 Rally Advanced A

11.1.1 This class shall be for dogs that have earned the RN title but have not earned the RA title or any CKC obedience title other than PCD. No handler who has exhibited a dog through its CKC CDX title or CKC RE title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. A person may enter more than one (1) dog in this class.

12.1 Rally Excellent A 12.

1.1 This class shall be for dogs that have earned the RA title, but have not earned the RE title or any CKC obedience title other than PCD. No handler who has exhibited a dog through its CKC CDX title, CKC RM title or CKC RAE title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. A person may enter more than one (1) dog in this class.
