CONFIRMATIONS

Confirmations will be emailed after the closing deadline. You must provide an email address for confirmation. Schedule of events will be included with confirmation.

SITE

Outdoors. Fenced. Some shade. Directions will be included with confirmation.

AWARDS

CARO qualifying ribbons will be awarded to each dog/handler team who achieves a score of 170 or better (except for Team where a qualifying score is 180 or above)

MOVE UPS

Move-ups from prior trials must be reported no later than one week prior to the trial. Please contact the Trial Secretary. We will attempt to also accommodate same day move-ups. NOTE: CARO rules state that you can compete concurrently at two levels (e.g., Novice and Advanced) but any qualifying scores earned at the higher level will only 'count' IF you complete the lower level title at the same trial.

FOOD

There will be NO concession on site; there are cafes and stores within a 10 minute drive.

CRATING AND SET-UP

The site will be available for set up after 10 am Friday morning. Lost or damaged personal property is not the responsibility of Love 2 Play. Valuables should not left in your car.

NOTICE TO COMPETITORS

Competitors, through submission of entry, acknowledge that they are knowledgeable of CARO Rally Obedience rules and regulations including, but not limited to, the following rules regarding entry:

- **Bitches in season are not permitted to** compete in these trials. Where a bitch comes into season after the entry of the bitch has been submitted, a Veterinarian's certificate, certifying the bitch was in season within the 10 day period preceding the Trial must reach the Trial Secretary on or before the date of the Trial, whereupon the entry fees will be refunded.
- **Dogs with disabilities are allowed** and encouraged to compete. Please let the trial secretary know of modifications that may be needed. The dogs must not show evidence of being in pain or discomfort. The judge shall excuse any dog that does so.
- **Owners with disabilities are allowed.** Owners with disabilities shall provide the judge with a written description of how they intend to perform any of the course exercises that must be modified. The modification must be approximate to the best of the handler's ability. The judge must approve and initial the modifications and attach the written description to the score sheet.
- **All dogs must be registered with CARO to compete in the obedience trial.** It is your responsibility to provide the Trial Secretary with your dog's CARO number prior to the closing date. If you do not have a CARO number, you may fill out an Individual Dog Application Form, and accompany it with a cheque made out to CARO for the amount required to the Trial Secretary. The Trial Secretary will then submit this application with the trial results.
- **Safety** shall always be of foremost consideration in actions and conduct by handlers at all times. Handlers, through entry at this event, accept full responsibility for themselves and the actions of their dogs.
- **Obstacles and stations** shall be chosen from those described in the rules and regulations of CARO and shall conform to this organization's specifications.
- It is expressly understood that competitors alone are responsible for the behaviour of their dogs and/or children. Any competitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behaviour may be asked to leave. NO REFUND of fees will be paid.
- All dogs must be penned, crated or on leash when not in the ring. All dogs must be under control when they leave the ring after their run. Any dog engaging in aggressive or out of control behavior when leaving the ring will be disqualified and/or required to leave the trial site. NO REFUND of fees will be paid.
- Exhibitors must keep crate and exercise areas clean. Please pick up after yourself and your dogs. We need to keep this great venue available for future dog events!
- There will be no refund after the closing date for dogs that are withdrawn, with the exception of bitches in season or sick/injured dogs if the Trial Secretary is notified prior to the trial date and provided with a vet's certificate.
- Trial organizers reserve the right to refuse any entry and if an exhibitor must be asked to leave the show grounds for any reason, they will not be issued a refund.
- No Physical corrections allowed on trial grounds.

All competitors will be encouraged to volunteer to help the trial run smoothly.

- **Allowable Collars** All dogs shall be shown in a flat buckle or snap collar or plain harness. NO choke collars, prong collars, shock collars, no pull harnesses, martingale collars / leads or head halters are allowed. Leashes should be made of fabric or leather and be long enough to provide adequate slack. Dogs at the Advanced and Excellent level are not required to compete with a collar; but must enter the ring on leash.
- Upon successful completion of an exercise, the owner may choose to briefly feed, pet or touch the dog as a reward at the Novice and Advanced levels. Toys may also be used. Food may NOT be used as a lure to help the dog complete an exercise. Food or toy rewards must be contained in pockets or hidden treat pouches on the opposite side from the dog and only be present in the owner's hand in between exercises. Any petting, touching, or feeding that significantly interrupts the flow of performance shall be scored accordingly.

GENERAL AGREEMENT

I (we) agree that **Love 2 Play Dog Training** has the right to refuse this entry for any cause, which the organizing committee alone shall deem to be sufficient. In consideration of the acceptance of this entry, of the holding of the event, and of the opportunity to have the dog participate and/or to be judged, I (we) agree to hold the organizing committee, the hosting club, the Canadian Association of Rally Obedience (CARO), including their members, officers, directors, agents and employees, sponsors of the event, and owners of the premises upon which the event is held and their employees, harmless from any claim for loss or injury that may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim. I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, appearance, theft, damage, or injury be caused or alleged to be caused by the negligence of the parties aforementioned, or by the negligence of any other person, or any other cause or causes. I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death resulting at any time therefore, sustained by any person or persons, including myself (ourselves), or on account of damage to property arising out of or in consequence of my (our) participation in this event, howsoever such injuries, death, or damage to property may be caused, and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.

I (we) further acknowledge that I (we) have read, understand, and will abide by the Official CARO Rules and Regulations of the Canadian Association of Rally Obedience and the provisions for entry as set forth in the Test Schedule of which this entry form is a part. I (we) acknowledge and represent that the information supplied by me (us) herein is correct to the best of my (our) knowledge; if any portion of this information is found to be invalid or insufficient to establish the validity of my (our) entry, such finding shall render my (our) entry invalid in its entirety, for which there shall be no refund of fees paid. Further, I (we) represent that I am (we are) the owner(s) of the dog listed hereon, or that I (we) am (are) a family member of the dog's owner as stated and allowed in the CARO Rally rules, and that I (we) shall hold the hosting club and CARO, including their officers, directors, employees and agents and their sponsors, harmless from any liability or claim made by dog's owner.

Further, I (we) hereby grant to **Love 2 Play Dog Training**, the Canadian Association of Rally Obedience (CARO), their representatives, agents, and assigns, all rights and permissions to broadcast, telecast, cablecast, transmission, or distribution in any format or media now known or hereafter to become known. I (we) hereby release CARO, the hosting club, their representatives, agents, and assigns from any claim or cause of action for invasion of the rights of privacy, right of personality, or any similar right.

All video, broadcast, and telecast rights for this event are the exclusive property of CARO or the trial host(s).
