12 – 18 Months	12 Months and under 18 Months on day of show.

Bred by Exhibitor	Dogs owned and handled in the ring by the breeder
Open	For all dogs

Temporary Competition Numbers: Self-serve Online Registration for Listed Dogs 

With the implementation of CKC's IT system, a new process requires all owners of unregistered, recognized breeds entering events to obtain a Temporary Competition Number (TCN). TCNs will replace the current system of entering events with "listed dogs", and will allow dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN). A TCN must be obtained before submitting an entry for an event and the same TCN must be used for all event entries for a dog until the dog is permanently registered. Once a dog is permanently registered or has an ERN, the TCN will be replaced with the registration number or ERN. A TCN cannot be used for Listed Breeds (MCN) or dogs that will require a (Performance Event Number) PEN or (Canine Companion Number) CCN. While there is no fee to obtain a TCN, exhibitors will still be required to pay TCN Fees (formerly called listing fees) when entering events using this number. The process of obtaining a TCN will be self-serve; exhibitors will be directed to the CKC website to complete an online application and a TCN will be issued instantly upon completion.

Exhibitors may also obtain a TCN by completing a printed application and submitting it to the CKC via mail, or by contacting the Shows and Trials Division by telephone. Until March 2, 2020 dogs may still be entered into CKC events without a registration number or ERN by marking "TCN" on the entry form (or "Listed" if it is an old entry form). However, an e-mail address will be required. Before you apply for a TCN online, exhibitors are encouraged to check their dog's profiles to determine if CKC has already created a TCN for them. There will be a tab for TCN Dogs on the Owner's Portal account. Please note that if your dog does not have a registration number or ERN, and has already competed in a CKC event and earned points, scores, or awards, there is no need to apply for a TCN. CKC records will be updated accordingly.

and create an account, you need an account to do your application online. Under Quick Links go to Register Dog and follow the instructions.

Please Note To support individuals entering events during CKC's current period of service delays, CKC will waive all TCN fees (previously known as listing fees) for all CKC events held between March 5th and May 5th, 2020.

New CKC Rule

Section 24-12-3. Non-member participation fee

- a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC.
- b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.

Points Are Not Awarded to Incorrect or Incomplete Entries

- When a dog is co-owned, the names of all owners must appear on the entry form.
- Enter the dog under its registered name, not its call name or another dog's name. The only exception is with listed dogs where the name may change upon registration.
- A foreign dog registered in another country must be entered under its registered name in the country of origin.
- All entry forms must be legible - type or print the information.
- **NEW RULE:** Section 8.2.5 Dog Show Rules: Effective Jan 1/06, an error in the class, date of birth or sex may be amended on the entry form up to one hour before the start of the show.

Chapter 20: Champions and Championship Points

Section 1. A dog awarded Winners at a Championship Show held under these Rules shall be accredited with a number of championship points (ranging from 0 to 5) and the determination of the number of championship points to be credited to a dog awarded WINNERS shall be as provided hereunder.

Section 2. The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows:

Dogs Competing*	1	2	3-5	6-9	10-12	13 or more
Points Allocated	0	1	2	3	4	5

*Includes the dog awarded Winners

Section 4. In addition to championship points allocated at the breed level a dog awarded WINNERS which also places in the regular Group competition as provided in Chapter 4, Section 8(j) of these Rules shall be credited with the following additional points, provided that the dog has defeated another dog at the group level, save that no more than five (5) points will be credited to a dog for a single show:

A class dog awarded Best In Show at an all-breed championship show will be credited five points inclusive of any points earned at the breed or group level. In no case may a dog earn more than five points at any single show.

General Information

The Show Superintendent will be in full charge of the Shows and Specialty Shows, which shall be governed by the Canadian Kennel Club Rules.

Print your entries carefully. Include your complete address. Errors made on entries by exhibitors or their agent must stand regardless of how or by whom entries were made.

No entry will be accepted unless accompanied by the correct entry fee. No refund of entry fees will be made if it is impossible to open or complete any show because of riot, civil disturbance, or other acts beyond the control of The Lakehead Kennel Club.

Entry fees will not be refunded should the dog be absent, sick, lame, in season, or excused by a Veterinarian, the Judge, or the Show Superintendent.

The Lakehead Kennel Club reserves the right to refuse any entry, subject to Canadian Kennel Club Rules.

Dogs must be ready for judging; individual dogs will not be called. Judges will not wait for any dog holding up a Breed or Group. Dogs not entered in the Show are not allowed in the Building.

Exercise areas must be used. The Show Committee will take all precautions and use all methods to keep the Building and surrounding area as clean as possible. Exhibitors are expected to do their part as well.

Due to limited space, private exercise pens will NOT be permitted, except in reserved grooming areas.

Lakehead Kennel Club will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of an accident, or other misfortune, to dogs, exhibitors or patrons. The welfare of an exhibitor's child is assumed to be the responsibility of the exhibitor.

Exhibitors shall exercise control and restraint over their children while attending these shows.

The show premises will be open not later than two hours before the scheduled judging time.

The precinct of the Show is the Arena, and parking area.
