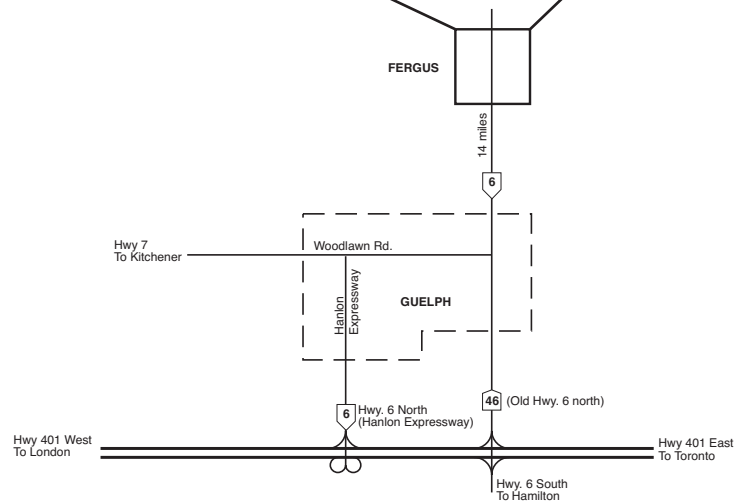
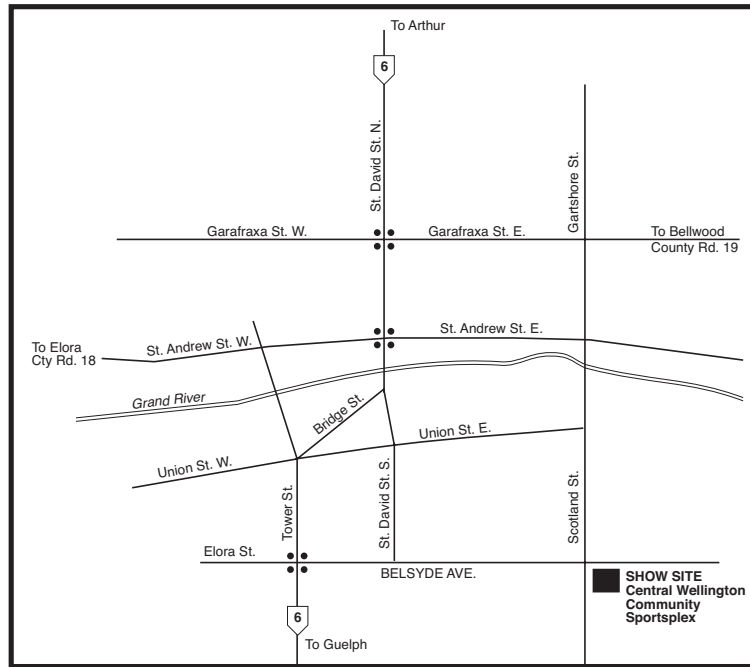

**CHAMPIONS AND  
CHAMPIONSHIP  
POINTS**

Chapter 15, Section 15.1.1 A dog awarded Winners at a conformation show shall be credited with a number of championship points (ranging from 0 to 5) and the number of championship points credited to a dog awarded Winners shall be as provided hereunder.

Section 15.1.2 The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows:

Dogs competing*	1	2	3 to 5	6 to 9	10 to 12	13 or more
Points allocated	0	1	2	3	4	5

\*includes the dog awarded Winners.

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge **SHALL NOT** be included in the calculation for championship points.

To determine the number of championship points earned by a dog awarded Winners, total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed, or Best of Opposite Sex and then consult the schedule set forth above.

Section 15.1.8 A Dog awarded Winners which also places in the regular Group competition shall be credited with the following additional points, provided that a dog was defeated at the group level, save that no more than five (5) points will be credited to a dog for a single show.

Section 15.1.11 A class dog awarded Best in Show at an all-breed Championship show will be credited with five points inclusive of any points earned at the breed or group level.

Section 15.1.12. In order for a dog to be recognized as a Champion and its owner provided with a Championship Certificate, the dog must have earned at least one 2 point win either at the breed or group level.

**MOVING CLASS  
DOGS TO  
SPECIALS**

Chapter 8, Section 8.9 of the Conformation Show Rules and Regulations has been amended to allow a dog which is individually registered in the records of the Canadian Kennel Club, and has completed the requirements for a Championship, after the Closing Date for entries for a show, may be transferred from one of the Regular Classes to "Specials Only", providing the request for a transfer is submitted to the Show Secretary in WRITING at least one hour prior to the opening of the show, by the owner or handler. Every day of a 2 or 3 day show is a separate show. Please note that this rule is effective up to one hour prior to the opening of the show, NOT one hour prior to the judging of the breed.

**CONFORMATION  
SHOW RULES AND  
REGULATIONS**

The Exhibitor is responsible for knowing and complying with the Conformation Show Rules and Regulations of the Canadian Kennel Club. Chapter 4 - Section 4.7.3 of the Conformation Show Rules and Regulations states: A judge officiating at a show held under these rules shall not be subjected to indignities of any kind during the progress of the show. It shall be the duty and obligation of the club holding the show to see that this rule is effectively carried out.

The Baby Puppy Class is for dogs 3 months and under 6 months on the day of the show. Dogs entered in the Baby Puppy Class do not compete for points. Puppies entered in this class will participate for Best Baby Puppy in Breed, Best Baby Puppy in Group and Best Baby Puppy in Show.

## HONEY ANNE GLENDINNING

I began exhibiting and breeding dogs in 1968. Since that time I have owned or bred English and Irish Setters, Newfoundlands, Dachshund, Dalmatian, Golden Retriever and an Alaskan Malamute. I started judging in 1982 and was approved for All Breeds by the Canadian Kennel Club in 1993. I have officiated at shows in Canada, the United States, England, Brazil, Mexico, Indonesia, Columbia, Hong Kong, China, Australia and N.Z.



In the US, I am approved to judge the Sporting Group, one Hound, several Working and Herding breeds, BIS, Juniors and on provisional for several breeds in the Working and Herding groups.

My English Setters were bred under the kennel name "Fantail" Perm. Reg. Champions to date number 86, including 6 BIS winners and numerous Specialty winners. Possibly the best known dog is Am Can Ch Fantail's Sunshine Man. Sonny had an impressive record in many fields. He was #1 dog All Breed, winner of the Canadian National, American National, 51 Best in Shows in Canada and 6 in the USA. Bred only 8 times he is behind some of the strongest bloodlines in North America.

## AUGUSTO BENEDICTO SANTOS III

More familiarly known as "Dinky" amongst his peers, he was born in 1967 to a family of "Animal Lovers". Dinky has been showing dogs for as long as he can remember. At an early age, he and his siblings often accompanied their Father to the dog shows. Together with his family, he was involved with German Shorthaired Pointers, Akitas from Japan, Bull Terriers, and German Shepherd Dogs before personally getting engrossed with the Labrador Retriever in 1988. Dinky's **Sunshadow Labrador Retrievers** is one of the main forces behind the success of the Philippine Labrador Retriever today. He owned PCCI's #1 Dog for 1996, #5 for 1995 and #3 for 1997. He has owned and bred more than 130 Champions – at least 70 of which are homebred. He also owned the #1 All-Breed "Sire of Champions" in the Philippines who, as of this writing, has sired forty six (46) Champions. He is presently involved with German Shepherd Dogs that he shows both in Germany and the Philippines. He presently owns "VA1 Sammo di Casa Beggiano" – a famous GSD and a leading sire in Germany. Dinky is also very much involved with Horses – a known SANTOS tradition. He was a member of the Philippine Equestrian Team and is presently, one of the Philippines' leading Polo Players. He is also involved with thoroughbred horse racing and has owned many Champions through the years.



Dinky was awarded the distinction "Life Member" of the PCCI in 2005. He was the founding President of the Labrador Retriever Club Incorporated (LRCI) back in 1994. He is a full-member of the prestigious Labrador Retriever Club (UK) and was bestowed "Honorary Life Member" of the Kennel Club of Pakistan. He has been a Philippine delegate to the Asia Kennel Union Conferences in 2006, 2008 and 2010; Federation Cynologique International General Assemblies held in 2007, 2009 and 2011; FCI Asia and the Pacific Section Conferences in 2006, 2008 and 2010.

He was the FCI observer for the FCI Asia and the Pacific Section Shows in 2009 and 2011. He was also a member of the FCI TASK FORCE that was formed in Bratislava.

He is presently a member of the General Committees of both the Asia Kennel Union (AKU) and the FCI Asia and the Pacific Section. Dinky has been a member of the Board of Directors of the Philippine Canine Club since 2003. He has held the positions of Assistant Corporate Secretary (2003-2005), Corporate Secretary (2005) President and Chairman simultaneously (2005-2008) and Chairman (2008-2010). He is presently the President and Chairman of the Philippine Canine Club (PCCI). He has judged all over Asia, Europe & South America. He is scheduled to judge in all continents of the world for 2012 including the Euro Dog Show in Romania, the world for 2012 including the Euro Dog Show in Romania.

## THEO HORCHNER

Theo Horchner is a well known Australian All Breed Judge and is rapidly developing an International profile most particularly in The Pacific, South East and Continental Asia and South Africa.



After commencing training in the early 1980s and successfully progressing through all seven groups in Australia, Theo was licensed as an All Breeds Judge in 2006. Theo is a Boxer specialist.

He was born into dogs. His parents had been exhibiting Boxers from the Internationally successful **Craigleigh Boxer Kennels**. During the 60's, 70's and 80's boasting many show winners, namely Ch. Craigleigh Bacardi, Ch. C Concerto, Ch. C Crescendo and Ch. C Cinzano. Later under their own **Stregaree** prefix came Ch. Stregaree She's Magic, Ch. S Sailing Home and many other important winners in Australia.

As a child Theo became a top class junior handler concentrating mainly on Boxers but also handling other breeds. As a junior handler he won at the prestigious Melbourne Royal Show, junior handlers and senior handlers in successive years. In recent years he has, in his own right, been a successful breeder and exhibitor of Boxers. He has met with success with a number of home-bred champions during this time.

It was inevitable that judging would follow. During his time as a judge Theo has had the great honor to judge in the following countries: Taiwan, New Zealand, Philippines, South Africa, Malaysia, India, Indonesia, Thailand, Singapore, Pakistan and of course all states of Australia.

Theo has also had considerable experience in dog club administration and championship dog show organization. He was the first and past president and founder of the South Eastern Kennel Club in Victoria, Australia. This club conducts a number of successful and popular shows each year usually with prestigious International judging panels.

Theo has judged at many specialty and semi specialty dog shows. He has also assisted in the judges' training scheme by giving lectures on various breeds to aspirant judges.

## LOIS WILSON

Lois was born in Rhodesia into a dog showing family, who had Setters, Spaniels and Airedales.



In 1980 she moved to South Africa and started **Sibra Kennels**, specialising in Siberian Huskies and later Shiba Inu's. She also owned GSD's and Border Collies, as well as handling a number of different breeds, making them up to Champions. Both her children took part in Junior Handling Competitions and she is a qualified Handler Judge.

Lois started judging in 1991, and is now qualified as an All Breeds Judge. She is the only qualified Breeder Judge of Siberians at Championship Show level in South Africa. Presently she is Chairman of the Kennel Union of Southern Africa's Executive Council.

Her judging appointments have taken her around the world, including Australia, Ireland, England, New Zealand, Thailand, Canada, USA, and Brazil.

An error in the class, date of birth or sex may be amended on the entry form up to one hour before the start of the show. Only dogs which are already registered in the Canadian Kennel Club Stud Book, or are eligible for such registration can be entered. The committee reserves the right to refuse any entry subject to CKC Rules.
- ENTRIES POSITIVELY CLOSE 8:00 P.M. (EST) WEDNESDAY, APRIL 4, 2012** and must be in the hands of the Show Secretary by that date.
- Identification Cards and Judging Schedules will be mailed as soon as possible after the entries close. Identification Cards must be presented upon arrival at the show.
- Tendering of NSF cheques in payment of fees shall be considered non-payment of fees and is punishable by disciplinary action. **Any N.S.F. cheques will be subject to a \$25.00 service charge.**

**GENERAL INFORMATION**

- The Show Superintendent will be in full charge of the show which will be governed by CKC Rules.
- The Guelph & District Kennel Club will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume liability in the event of accident, or other misfortunes, to either dogs, exhibitors or patrons.
- If, because of riot, civil disturbance or other acts beyond the control of management, it is impossible to open or to complete the show, no refund of Entry will be made.
- Dogs should arrive in adequate time for their breed judging (allowing for absentees) and will be excused each show when not required for further judging. It is the responsibility of the exhibitors to have the dog at ringside when the dog's class is scheduled for judging. Waiting for dogs will not be possible and handlers with several breeds must arrange for alternate handlers if judging times for their breeds conflict.
- Judging will commence at 8 a.m. Friday, April 20, Saturday, April 21 and Sunday, April 22, 2012. A later starting time may be specified in the judging schedule. Starting time of each ring will be specified in the judging schedule.
