

Day of trial competitive entries, on a paper entry form, may be accepted on the day of the trial, no later than 1 hour before the start of the trial. Acceptance of the entry is at the discretion of the show secretary and obedience chairperson and subject to the influences of scheduling and amount of judges time available. There is a \$6./class additional fee. We will create a Standby list if you indicate by email whether you would like to enter. We will advise if there is time available.

Special Note:

Obedience is full. CGN testing is full. Rally has time available.

Building opens at 7:00 am on Saturday and Sunday. Move-in from 2:00 to 5:00 on Friday.

Day of Trial Entries begin at 7:00 am on Saturday. Building closes 30 minutes after High in Trial or the final rally class.

While there is limited heat in the arena (top of the bleachers), you should dress warmly and bring a chair.

There is no concession in the building. Sunday, the building to the west hosts a market which has a concession.
