If you send a cheque in US Funds it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not make cheques "Payable In Canadian Funds", they will not be cleared by the banks. To simplify the process, we urge you to purchase bank drafts or money orders payable in Canadian Funds. Your understanding and cooperation is appreciated. Thank you.

NON MEMBER PARTICIPATION FEE

An annual "Non-member" participation fee for Awards and Titles will be charged to a Canadian "non member" of the Canadian Kennel Club. This fee will match the fee charged for Event Registration Number.

In order to protect the Awards and Titles earned, the "non-member" will have a choice to (a) either become a CKC member; or (b) pay the "non-member" participation fee. Failure to comply within 30 days of notification will cause All Awards and Titles to be cancelled.

Please Note: These fees only apply to dogs wholly owned by "Non-CKC" members and are not applicable to CKC members.

CONFORMATION CLASSES

Baby Puppy	A dog 3 months up to 6 months on the day of the show.
Junior Puppy	A dog 6 months up to 9 months on the day of the show.
Senior Puppy	A dog 9 months and up to 12 months on the day of the show.
12-18 Months	A dog between 12 months and up to 18 months on the day of the show.
Canadian Bred	A dog which was born in Canada.
Bred by Exhibitor	A dog owned and handled by the breeder.
Open Class	A dog 6 months of age or older
Specials Only	Dogs who are Canadian Champions.
Altered Class	Dogs 6 months and older who have been neutered or spayed by a veterinarian. Altered dogs attaining Winners Male and Winners Female may earn Altered Championship points.
Veteran Class	A dog that is 7 years or older the day of the show
Exhibition Only	Dogs 6 months of age and over not in competition. Dogs 3 months of Age and under 6 months on the day of the show may be entered in Exhibition Only providing that the owner of the puppies has also entered a dog in one of the Regular official classes. No exhibitor may enter more than 2 puppies.

NOTE: 3-6 month Baby and Exhibition only puppies~ if the puppy does not yet have a CKC Registration Number the Listing Fee of \$9.80 is waived.

Champion & Championship Points ~ Chapter 1 Section 1 ~ A dog awarded Winners at a Championship Show held under these Dog Show Rules shall be credited with a number of Championship points (ranging from 0 to 5) and the determination of the number of championship points to be credited to the dog awarded winners shall be as provided hereunder:

A class dog awarded Best In Show at an All Breed Championship Show will be credited with five points inclusive of any points won at the Breed or Group level. In no case may a dog earn more than five points at a single show. **NOTE: In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall NOT be included in the calculation of Championship Points.**

NON-PUREBRED DOGS IN OBEDIENCE AND RALLY TRIALS

Non-purebred dogs will be accepted in both Obedience and Rally Obedience Trials. If entering your non-purebred dog in either of these trials, your dog will be required to have a Canine Companion Number. Please check the CKC Policy and Procedures Manual Chapter 6.34 (found on line at the CKC website) for requirements to obtain your dog's CCN.

OBEDIENCE CLASSES

Novice A & B, Open A & B, Utility A & B (Pre Novice, Novice C & Novice Intermediate)

RALLY OBEDIENCE CLASSES

Exhibitors entering both obedience and Rally must fill out separate entry forms
Rally Obedience Classes are as follows: Novice "A", Novice "B", Intermediate, Advanced "A", Advanced "B" Excellent "A" and Excellent "B"

BITCHES COMING INTO SEASON

Bitches coming into season MAY NOT compete in Obedience or Rally Trials. Entry fees will be refunded ONLY if the Trial Secretary receives a Veterinarian's Certificate PRIOR to the commencement of the Trial.

EVENT REGISTRATION NUMBER (ERN)

All dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will require and Events Registration Number (ERN). To obtain an ERN simply do the following:

1. send a photocopy of the dog's Registration Certificate reflecting current ownership, for example AKC Registration Certificate with a written request for an ERN.
2. Include with the above a cheque or money order in the amount currently required payable to the Canadian Kennel Club.
3. Ensure that you provide the CKC with your full return address to enable the ERN to be sent to you
4. Faxed requests will be accepted. Please indicate your VISA/MasterCard number and expiry date, the card holders name and signature.

This Event Registration Number **MUST** be applied for within 30 days of the first day of entering a CKC event. Dogs may be entered as "LISTED", however, failure to apply for an ERN within 30 days will result in cancellation of any wins, awards or scores.
