### **GENERAL INFORMATION**

The Trial Superintendent will be in full charge of the trial, which will be governed by CKC rules.

The German Shepherd Dog Club of London will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume liability, in the event of accident or other misfortunes, to either dogs, exhibitors or patrons.

If, because of riot, civil disturbance, or other acts beyond the control of management, it is impossible to open or complete the trials, no refund of Entry Fees will be made.

The trial precincts shall be the grounds at Cardshark Canine.

CKC 4.1.5 "It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer or competitor at an Obedience Trial held under these regulations is not subject to indignities of any kind. The Obedience Trial Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred."

Collars, Leashes and Harnesses: 9.4.1 "Dogs must wear a properly fitted collar or harness approved by the judge. The harness will be constructed of plain, pliable material and will be designed so that there is minimal restriction of the dog's movement. No special training tools, such as electronic collars, prong collars, head halters, choke chains or pull harnesses may be used during the search. Martingale collars are permitted. No odor emitting collars (such as no-bark collars that spray citronella, or DAP calming collars) may be worn or present in the search area.

#### LIABILITY

I accept full responsibility for all statements made in this entry.
